ORS 537.705 and ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

# **Findings of Fact**

- 1. On February 27, 2006, Stan Adams filed a transfer application to add an additional point of appropriation to the Points of Appropriation authorized under Certificates 75733 and 75816. The Department assigned the application number T-10103.
- 2. The portion of the first right to be transferred is as follows:

Certificate: 75733 in the name of STAN ADAMS perfected under Permit G-7364

**Use:** IRRIGATION of 90.9 ACRES **Priority Date:** FEBRUARY 9, 1977

Rate: 1.134 CUBIC FEET PER SECOND (CFS); BEING 0.378 CFS from WELL #1 and

0.756 CFS from WELL #2

Limit/Duty: ONE-EIGHTIETH cfs per acre, not to exceed 3.0 acre-feet per acre per year

Source: WELLS #1 & #2, in the FORT ROCK BASIN

5. Application T-10103 proposes to add an additional point of appropriation approximately ¼ mile South of Well #1, located:

- 6. Notice of the application for transfer was published on March 14, 2006, pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
- 7. Water has been used within the last five years according to the terms and conditions of the rights, and no evidence is available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.

- 8. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights are present.
- 9. The proposed change would not result in enlargement of the rights.
- 10. The proposed change would not result in injury to other existing rights.
- 11. On May 10, 2006, the Department issued a preliminary determination proposing to approve Transfer T-10103 and mailed a copy to the applicant. Additionally, notice of the preliminary determination for the transfer application was published on the Department's weekly notice on May 16, 2006, and in the Lake Count Examiner newspaper on May 25 and June 1 and 8, 2006 pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

## **Conclusions of Law**

The proposed additional point of appropriation in T-10103 is consistent with the requirements of ORS 537.705 and ORS 540.505 to 540.580, and OAR 690-380-5000.

## Now, therefore, it is ORDERED:

- 1. The proposed additional point of appropriation in T-10103 is approved.
- 2. Water right certificates 75733 and 75816 are cancelled. A new certificate will be issued describing that portion of the right evidenced by Certificate 75733 not involved in this transfer.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 75733 and 75816 and any related decree.
- 4. Water shall be acquired from the same aquifer (water source) as the original points of appropriation.
- 5. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2007.** A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 6. The quantity of water diverted at the new point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriations.
- 7. Prior to diverting water at the new point of appropriation, the water user shall install and maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
