ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 9449 submitted by

GARY L. ROBINSON AND KAREN D. JOHNSON 4430 ANDREA DRIVE NW SALEM, OREGON 97304.

The right to be modified, as evidenced by a portion of Certificate 8499, was perfected under Permit 7068 with a date of priority of NOVEMBER 30, 1925. The right allows the use of A SPRING, a tributary of BALDWIN CREEK (EAST FORK HOOD RIVER), for DOMESTIC USE, INCLUDING IRRIGATION OF LAWN AND GARDEN. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.05 cubic foot per second, if available at the authorized point of diversion: NW¼ SW¼, SECTION 34, T 1 N, R 10 E, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated during the irrigation season of each year.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

NW¼ SW¼ SECTION 34

TOWNSHIP 1 NORTH, RANGE 10 EAST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the place of use to:

NW¼ SW¼ SECTION 34

TOWNSHIP 1 NORTH, RANGE 10 EAST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 2005.
- 2. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 8499 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
