ORDER APPROVING A CHANGE IN APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7279 submitted by

PEMBROKE FARMS
7017 QUARRY AVE NE
SILVERTON, OR. 97381

The right to be modified, as evidenced by Certificate 67667, was perfected under Permit G-9522 with a date of priority of MARCH 23, 1981. The right allows the use of A SUMP, a tributary of the ABIQUA CREEK BASIN, for SUPPLEMENTAL IRRIGATION OF 73.3 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.74 cubic foot per second, if available at the original well; NW¼ SW¼, SECTION 23, T.6S. R.1W. W.M.; 2150 FEET NORTH AND 400 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 23, or its equivalent in case of rotation, measured at the well

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

NE $\frac{1}{4}$ SE $\frac{1}{4}$ 8.3 ACRES

SE $\frac{1}{4}$ SE $\frac{1}{4}$ 7.6 ACRES

SECTION 22

NE $\frac{1}{4}$ SW $\frac{1}{4}$ 8.0 ACRES

NW $\frac{1}{4}$ SW $\frac{1}{4}$ 17.4 ACRES

SW $\frac{1}{4}$ SW $\frac{1}{4}$ 26.9 ACRES

SE $\frac{1}{4}$ SW $\frac{1}{4}$ 5.1 ACRES

SECTION 23

TOWNSHIP 6 SOUTH RANGE 1 WEST W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the POINT OF APPROPRIATION to:

NW $\frac{1}{4}$ SW $\frac{1}{4}$ SECTION 23, T.6S. R.1W. W.M.; 2000 FEET NORTH AND 1000 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 23.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1997.
2. The quantity of water diverted at the new point of appropriation (well) shall not exceed the quantity of water lawfully available from the original point of appropriation.
3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 67667 is canceled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
