APPEALS LANGUAGE

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.


August 7, 2014, the Oregon Water Resources Department (OWRD) received requests to assign the licensee of hydroelectric projects HE 601, HE 602, HE 603, and HE 604 from Lucid Energy, Inc. to Conduit 3, LLC.

August 13, 2014, the Oregon Water Resources Department (OWRD) received Conduit 3, LLC's notarized Acceptance of Hydroelectric Terms & Conditions form in consideration for the assignment of rights and privileges evidenced by the time-limited certificates covering Hydroelectric Projects HE 601 (Certificate 89129), HE 602 (Certificate 89130), HE 603 (Certificate 89131), and HE 604 (Certificate 89132) from Conduit 3, LLC. On this form the Conduit 3, LLC promised and agreed to exercise such rights and privileges, associated with the hydroelectric projects, in conformity to the laws of the State of Oregon, conditions imposed in said certificates, and the rules and regulations of the Water Resources Commission made pursuant thereto.

Conduit 3, LLC appears to have the qualifications of a licensee consistent with the laws of the State of Oregon and rules of the Water Resources Department made pursuant thereto.

Therefore, it is ordered that the assignments for hydroelectric projects HE 601, HE 602, HE 603 and HE 604, and their respective water right Certificates 89129, 89130, 89131 and 89132, to Conduit 3, LLC are hereby approved. Superseding certificates will be issued to confirm the assignments from Lucid Energy, Inc. to Conduit 3, LLC.
