ORDER APPROVING
TRANSFER 5342

On August 8, 1983 an application was filed in the office of the Water Resources Director by Alfred H. and Nancy deC Corbett for approval of a change in place of use of water from Tumalo Creek, Deschutes River, Crater Creek, Little Crater Creek and three spring branches, and Crescent Lake Reservoir, pursuant to the provisions of ORS 540.510 to 540.530.

By Decree of the Circuit Court for Crook County, Oregon, entered May 1, 1911, In the Matter of the Determination of the Relative Rights to the Use of the Waters of Tumalo Creek, a tributary of Deschutes River, water rights were allowed in the names of J.J. Coen, tabulated at page 137, Volume 1, for irrigation of, among other lands, a certain 0.9 acre in NW 1/4 NE 1/4, Section 1; and Fred W. Simmons, tabulated at page 138, Volume 1, for irrigation of, among other lands, a certain 2.0 acres in SW 1/4 NE 1/4, Section 1, both in Township 17 South, Range 11 East, WM, with a date of priority of September, 1900, as evidenced by the certificate issued in the name of Tumalo Irrigation District and recorded at page 31410, Volume 23, State Record of Water Right Certificates.

By Decree of the Circuit Court for Deschutes County, Oregon, entered August 27, 1958, In the Matter of the Determination of the Relative Rights to the Use of the Waters of Tumalo Creek, a tributary of Deschutes River, a water right was allowed in the name of Deschutes County Municipal Improvement District (now Tumalo Irrigation District), tabulated in the name of E.W. Armstrong at page 197, Volume 16, for irrigation of, among other lands, a certain 0.4 acre in NW 1/4 NE 1/4, Section 1, Township 17 South, Range 11 East, WM, with a date of priority of September, 1900, as evidenced by the certificate issued in the name of Tumalo Irrigation District and recorded at page 26508, Volume 18, State Record of Water Right Certificates.

These lands also have supplemental rights evidenced by Certificate 31412, Volume 23, State Record of Water Right Certificates, to the use of water from Deschutes River, with a date of priority of 1905; Certificate 26050, Volume 18, to the use of water from Tumalo Creek, Crater Creek, Little Crater Creek and three spring branches, with a date of priority of October 29, 1913; Certificate 26051, Volume 18, to the use of waters of Crescent Lake Reservoir, with a date of priority of April 7, 1911; and Permit 27841 for the use of waters of Crescent Lake Reservoir, with a priority date of December 8, 1961.

The applicants herein, owners of the lands described above, propose to transfer the water rights therefrom to a certain 0.8 acre in SE 1/4 NW 1/4 of Section 1 (Certificate 31410), 0.4 acre (Certificate 26508) and 2.1 acres (Certificate 31410) in NW 1/4 NE 1/4, Section 2, all in Township 17 South, Range 11 East, WM.

The lands involved herein are within the boundaries of the Tumalo Irrigation District and the Board of Directors of said District approved the proposed change in place of use of water at a regular meeting.

Robert F. Main, Jr., Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.


No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use is approved, without loss of priority.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1985.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of complete application of water to beneficial use on the lands to which the water is transferred hereby, the change of water right is considered perfected, and at a later date a certificate of water right shall be issued to Tumalo Irrigation District confirming this and other changes within the District, and superseding Certificates 31410 and 26508.
