**AMENDED ORDER OF THE OREGON WATER RESOURCES DEPARTMENT
APPROVING A TEMPORARY CHANGE IN PLACE OF USE IN AN IRRIGATION
DISTRICT**

Pursuant to ORS 540.570, after the Department published notice in summary form, and no objections were filed; and pursuant to ORS 540.570 (3) and OAR 690-21-060 (2) finding the amended place of use presented no injury to existing water rights or resulted in an enlargement of existing rights; this order approves as conditioned or limited herein, **AMENDED TEMPORARY DISTRICT TRANSFER 8687** submitted by:

I.

The first water right to be modified, as evidenced by a portion of Certificate 74897, was perfected under Permit G-4969. The date of priority is June 8, 1971.



THE PROPOSED TEMPORARY CHANGES TO THE EXISTING DISTRICT WATER RIGHTS FOR THE 2001 IRRIGATION SEASON MAY BE MADE SUBJECT TO THE FOLLOWING CONDITIONS:

1. Pursuant to OAR 690-21-060(3), this order amends the order approving District Temporary Transfer T-8687, signed April 2, 2001.
2. This amended order applies only to Section I and modifies the authorized places of use under Certificate 74897.
3. Pursuant to 540.570(2) water may not be used on either the authorized places of use or proposed places of use prior to April 10, 2001.
4. The authorized places of use will receive no water under any other appurtenant water rights during the 2001 irrigation season unless water rights are transferred to these lands.
5. The use of water for supplemental irrigation under Permit G-8907 may not be exercised on any of the lands subject to this order.
6. All restrictions and limitations contained in the decree or permit of the subject rights will apply to the lands described by the change in place of use. Water use from wells in the Butter Creek and Stage Gulch Critical Ground Water Areas subject to allocation under OAR Chapter 690, Division 507 shall not exceed any limitations imposed by administrative rule.
7. Pursuant to 540.570(6) the Department may further condition or revoke a temporary transfer at any time to the extent necessary to avoid injury if the department finds the transfer is causing injury to an existing water right.
8. Pursuant to 540.570(7), upon expiration of the temporary transfer period, all uses of water for which a temporary transfer is allowed under this section shall revert automatically to the location, terms and conditions of the original water right permit, certificate or an adjudication proceeding under ORS chapter 539 as evidenced by a court decree.
