FINDINGS OF FACT

1. A Pooled Short-Term Lease Application, which proposed to lease a portion of certificates 74197, primary from the Deschutes River, tributary to the Columbia River, and 76714, supplemental from Crane Prarie Reservoir, tributary to the Deschutes River, for instream purposes was submitted to the Department on April 16, 2004, by:

2. The Department assigned this lease agreement number L-519.

- 5. The Department finds that the lease application requires modification to clarify the following:
 - a. The quantity of water that may be leased instream under each priority date for certificate 74197 as well as the portion of that certificate needs clarification. During Season 3, this water right allows the diversion of 1/20.8th CFS for each acre to which water is applied. Water under this right, may be used on 4384.05 acres, including equivalent acres for uses other than irrigation. If water were being applied to all acres allowed by the certificate, the amount that could be diverted in Season 3, 210.77 CFS, would exceed the rate limitation on the certificate, 150.0 CFS, being 25.0 CFS under February 1, 1905 and 125.0 CFS under April 25, 1905. To identify the portion of this certificate that may be leased in Season 3, the Department has proportioned the 150.0 CFS allowed by the certificate to each acre on which water may be applied, which amounts to 1/29.2nd CFS per acre.
 - b. The source of water and portion of the supplemental right, certificate 76714, which may be leased instream.

- c. The correct duty for irrigation of 20.39 acres. The lease application incorrectly described the duty limit as 15.42 AF for certificate 74197.
- d. The portion of each right to be leased instream from each POD, being POD #6 and POD #1 (Arnold Canal).
- 6. Therefore, based on Finding 5, these rights are clarified as follows (modifications shown in bold text):

7. The application proposes to lease water for instream as follows:

Reach: From the canal diversion at River Mile 174.5 to Lake Billy Chinook.

8. The Department finds that in order to prevent injury and enlargement the applicant's request must be modified considering the findings made in Finding 5 above. Specifically, the rate at which water is to be leased instream under the primary right has been broken down by priority date and the rate in Season 3 has been modified to reflect a proportioned rate. The volume of water to be leased instream under the primary right has also been modified. At the rates identified below, only 29.79 AF from POD #1 and 57.6 AF from POD #3 may be leased during the full period requested. The quantity of water that may be leased instream under the supplemental right has also been modified to reflect a proportioned volume. Finally, the

- reach has been modified to separate the amount of water that may be protected instream from each point of diversion.
- 9. Therefore, based on Finding 8, the Department finds that water may be leased instream as follows (changes are shown in bold text):

Reach: From POD #1 (Arnold Canal) (T18S, R11E, Section 27, W.M.; 2800 feet South & 3740 feet West from the NE Corner of Section 27) to Lake Billy Chinook.

- 10. To prevent injury an enlargement, the amount of water to be leased instream under certificate 74197 accounts for a 65% transmission loss that may not be leased and protected instream.
- 11. Certificate 76714 is supplemental to certificate 74197. The portion of certificate 76714 being leased instream shall only be protected instream if the full rate and duty under certificate 74197 are not available during the period for which water is being leased instream.
- 12. Based upon review of the application and information provided by the Department's Watermaster and other available information, the Department finds that the lease, as proposed and modified above, will not result in injury or enlargement.
- 13. The lease will terminate on October 31, 2008. The lessor has requested the option of terminating the lease early, with written notice to the Department.

CONCLUSIONS OF LAW

The Department concludes that the lease, as modified above, will not result in injury or enlargement, OAR 690-077-0077.

ORDER

Therefore, it is ORDERED:

- 1. That the Short-Term Lease described herein is APPROVED.
- 2. The authorized place of use shall not be irrigated during the term of this lease.

3. Water is leased instream as follows:

Reach: From POD #1 (Arnold Canal) (T18S, R11E, Section 27, W.M.; 2800 feet South & 3740 feet West from the NE Corner of Section 27) to Lake Billy Chinook.

- 4. Certificate 76714 is supplemental to certificate 74197. The portion of certificate 76714 being leased instream shall only be protected instream if the full rate and duty under certificate 74197 are not available during the period for which water is being leased instream.
- 5. The lease will terminate on October 31, 2008. The lessor shall have the option of terminating the lease each year, prior to the lease being exercised (April 1), with 30 days written notice to the Department.
