Authority

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

- 1. On September 27, 2012, ZACH CHRISTENSEN of CHRISTENSEN FARMS LLC filed an application for an additional point of diversion under Certificates 16716, 19861, 22486, 47042, 49960, 49961, 50648, 64516 and 87465 and to change the place of use under Certificates 16716, 19861, 22486, 47042, 49961, 64516 and 87465. The Department assigned the application number T-11478.
- 2. Notice of the application for transfer was published on October 2, 2012, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. On August 13, 2014, the Department mailed a copy of the draft Preliminary Determination proposing to deny Transfer Application T-11478 to the applicant because of injury to instream water right Certificates 72978 and 80357. The draft Preliminary Determination cover letter set forth a deadline of September 12, 2014, for the applicant to respond.
- 4. On September 16 and October 9, 2014, the applicant requested that the Department seek a recommendation from the Oregon Department of Fish and Wildlife (ODFW) and the Oregon Department of Environmental Quality (DEQ), as to whether the Department should

consent to injury of the instream water right pursuant to OAR 690-380-5030, and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.

- 5. On November 13, 2014, the Department issued a Preliminary Determination proposing to deny Transfer Application T-11478 unless ODFW and DEQ recommend consent to injury, and sent a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on November 18, 2014 and in the McMinnville News Register newspaper on November 21 and 28, 2014, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notices.
- 6. On November 14, 2014, requests were sent to ODFW and DEQ for recommendations concerning consent to injury of instream water rights under Certificates 72978 and 80357.
- 7. On January 22, 2015 and February 10, 2015 recommendations were received from ODFW and DEQ in favor of consent to injury of the instream water rights.
- 8. Notice of the agencies' recommendations was published on February 24, 2015, pursuant to OAR 690-380-5050. No comments or requests for a public meeting were filed in response to the notice.
- 9. ODFW and DEQ recommendations stated that the consent to injury should be contingent upon approval of Transfer Application T-11876 point of diversion and place of use change. And ODFW has determined that a fish screen is required at the new point of diversion prior to prior to the diverting of the water.
- 10. On March 30, 2015, the Department issued a Final Order, recorded at Special Order Volume 95, Pages 332-344, approving transfer application T-11478, and issuing remaining right Certificates 90045, 90046, 90047, 90048, 90049, 90050, and 90051.
- 11. On September 28, 2016, scriveners' errors were discovered in the description of the place use on multiple certificates and the remaining right certificates were issued in error. This order is issued to correct the scrivener's errors and supersedes the previous order recorded at Special Order Volume 95, Pages 332-344, and should cancel remaining right Certificates 90045, 90046, 90047, 90048, 90049, 90050, and 90051. All changes can be found in **bold**.

37. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screen is necessary at the new point of diversion to prevent fish from entering the diversion and that the diversion is not currently equipped with an appropriate fish screen. This diversion may be eligible for screening cost-share funds.

Transfer Review Criteria [OAR 690-380-4010(2)]

- 38. Water has been used within the five-year period prior to submittal of the transfer application according to the terms and conditions of the right. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 39. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-11478.
- 40. The proposed changes would not result in enlargement of the rights.
- 41. Instream water rights, Certificate 72978 and 80357, exists for the reach of the river in which the additional point of diversion for Certificates 47042, 49960, 50648 and 87465, would be located upstream, and stream flows within the reach are frequently below the levels allocated under the instream water rights. Thus, the instream water rights would be injured as a result of the additional point of diversion associated with Certificates 47042, 49960, 50648, and 87465.
- 42. The reach of the river between the existing points of diversion and the additional point of diversion is within the reach of instream water rights located on the South Yamhill River described on Certificates 72978 and 80357.

Conclusion of Law

Based on the recommendation of the Oregon Department of Fish and Wildlife and the Oregon Department of Environmental Quality, the Department consents to injury of the instream water right evidenced by Certificates 72978 and 80357. The additional point of diversion and changes in place of use proposed in Transfer Application T-11478 are consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000, 690-380-5030 and 690-380-5050.

Now, therefore, it is ORDERED:

- 1. The order recorded at Special Order Volume 95, Pages 332-344, is withdrawn and of no further force or effect and is superseded by this order.
- 2. Certificates 90045, 90046, 90047, 90048, 90049, 90050, and 90051 are cancelled.
- 3. The additional point of diversion and changes in place of use proposed in Transfer Application T-11478 are approved.
- 4. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 16716, 19861, 22486, 47042, 49960, 49961, 50648, 64516 and 87465 and any related decree.
- 5. Water right Certificates 16716, 19861, 22486, 47042, 49960, 49961, 50648, 64516 and 87465 are cancelled.
- 6. The quantity of water diverted at the additional point of diversion, together with that diverted at the original points of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion.
- 7. Water use measurement conditions:
 - a. **Before water use may begin** under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each point of diversion (new and existing).
 - b. The water user shall maintain the meters or measuring devices in good working order.
 - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- 8. Prior to diverting water, the water user shall install an approved fish screen at the new point of diversion and shall provide to the OWRD a written statement from ODFW that the installed screen meets the state's criteria, or that ODFW has determined a screen is not necessary.
 - The water user shall operate and maintain the fish screen at the new point of diversion consistent with ODFW's operational and maintenance standards. If ODFW determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.
- 9. The former place of use of the transferred rights shall no longer receive water under the rights.

- 10. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2016**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 11. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.
