ORDER
APPROVING APPLICATION

On October 28, 1963, Mrs. Grace Taylor of Corvallis, Oregon, filed an application in the office of the State Engineer for the approval of a change in point of diversion of water from a well, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to Mrs. Zack Taylor and recorded at page 28583, Volume 20, State Record of Water Right Certificates, confirms a right for the use of the waters of Taylor Well No. 1 for the irrigation of 2.0 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ and 6.8 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within P. Robinett D.L.C. No. 37, and 5.0 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, 5.0 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, 15.6 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, 18.7 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, 0.5 acre in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ and 1.5 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within J. Robinett D. L.C. No. 52; all being in Section 6, Township 12 South, Range 4 West, W.M., with a date of priority of February 6, 1957. These lands are irrigated from Taylor Well No. 1, the point of diversion of said well being located South 37 degrees East 3227 feet from the northwest corner of Section 6, and being within the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within J. Robinett D.L.C. No. 52, in Section 6, Township 12 South, Range 4 West, W.M.

The applicant herein, owner of the lands above described, proposes to irrigate said lands by means of a well, the point of diversion of said well being located South 35 degrees 45' East 3514 feet from the northwest corner of Section 6, and being within the NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within J. Robinett D.L.C. No. 52, Section 6, Township 12 South, Range 4 West, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason said section provides notice is not required on an application for a change in point of diversion of water of less than one-fourth mile where there are no intervening diversions.

Mr. Jack E. Sceva, Geologist for this Department, has filed a report to the effect that the proposed change in point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the change in point of diversion of water from a well, to-wit:

From a point located South 37 degrees East 3227 feet from the northwest corner of Section 6, and being within the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within J. Robinett D.L.C. No. 52, in Section 6, Township 12 South, Range 4 West, W.M.

To a point located South 35 degrees 45' East 3514 feet from the northwest corner of Section 6, and being within the NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within J. Robinett D.L.C. No. 52, Section 6, Township 12 South, Range 4 West, W. M.


for the irrigation of 2.0 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ and 6.8 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within P. Robinett D.L.C. No. 37, and 5.0 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, 5.0 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, 15.6 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, 18.7 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, 0.5 acre in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ and 1.5 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within J. Robinett D.L.C. No. 52, all being in Section 6, Township 12 South, Range 4 West, W. M., with a date of priority of February 6, 1957, is approved.

It is FURTHER ORDERED that no time need be fixed for completion of construction as the well is constructed and in operation.

It is FURTHER ORDERED that certificate of water right heretofore issued to Mrs. Zack Taylor and recorded at page 28583, Volume 20, State Record of Water Right Certificates, is canceled and upon receipt of proof satisfactory to the State Engineer of completion of point of diversion, a certificate of water right shall be issued to Mrs. Grace Taylor confirming said change in point of diversion.
