On April 14, 1937, Irrigation Canal Company, of La Grande, Oregon, filed an application with Chas. E. Stricklin, State Engineer, for the approval of a change in point of diversion of water from Grande Ronde River.

By decree of the court for Union County, dated August 8, 1925, in the matter of the determination of the relative rights to the use of the waters of Grande Ronde River and its tributaries, water rights were recognized in the names of the following individuals for irrigation from Grande Ronde River through the Irrigation Canal Company's ditch, the point of diversion of said ditch being located approximately 880 feet North and 1280 feet East from the Southwest corner of Section 31, Township 2 South, Range 38 East, W. M.:

The applicant herein proposes to change the present point of diversion to a point up-stream to be located approximately 400 feet North and 200 feet East from the Southwest corner of Section 31, Township 2 South, Range 38 East, W. M.

Notice of filing application for a change in point of diversion of water, as provided by Section 47-712, Oregon Code 1930, was given by publication in the Eastern Oregon Review for four consecutive issues, the first issue being dated April 23, 1937 and the last May 14, 1937.

No objections having been filed, it appears that such a change in point of diversion can be made without injury to existing rights.

NOW, THEREFORE, it hereby is ORDERED that the present point of diversion located approximately 880 feet North and 1281 feet East from the Southwest corner of Section 31, Township 2 South, Range 38 East, W. M., be and the same hereby is changed to a point to be located approximately 400 feet North and 200 feet East from the Southwest corner of Section 31, Township 2 South, Range 38 East, W. M.
