Authority

Findings of Fact

Background

- 1. On March 18, 2009, Avion Water Co., Inc., filed an application to change the points of appropriation, an additional point of appropriation and to change in place of use under Permit G-10019. The Department assigned the application number T-10828.
- 2. The permit to be amended is as follows:

6. Notice of the application for the permit amendment was published in the Department's weekly notice on April 7, 2009 pursuant to ORS 540.520(5). No comments were filed in response to the notice.

Permit Amendment Review Criteria

- 7. The changes would not result in injury to other water rights.
- 8. The proposed place of use is controlled by the permit holder.
- 9. The changes do not enlarge the permit.
- 10. The changes do not alter any other terms of the permit.
- 11. The proposed place of use is contiguous to the authorized place of use.

Conclusions of Law

The change in points of appropriation, additional point of appropriation and change in place of use proposed by Permit Amendment Application T-10828 is consistent with the requirements of ORS 537.211.

Now, therefore, it is ORDERED:

The changes and subsequent use of water shall be subject to the following conditions:

- 1. The quantity of water diverted at the new points of appropriation shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 2. The combined quantity of water diverted at the additional point of appropriation, together with that diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 3. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.
- 4. Water shall be acquired from the same aquifer as the original points of appropriation.
- 5. All other terms and conditions of Permit G-10019 remain the same.
- 6. Permit G-10019, in the name of AVION WATER CO., INC., is amended as described herein.
