On December 20, 1983, an application was filed in the office of the Water Resources Director by Advancement Irrigation District for approval of a change in place of use of water from Owyhee River, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 24707, Volume 17, State Record of Water Right Certificates, in the name of United States of America, Bureau of Reclamation, describes a right which includes the use of not to exceed 0.33 cubic foot per second from Owyhee River, for irrigation of 20.0 acres in SW 1/4 NE 1/4, Section 5, Township 18 South, Range 47 East, WM, with dates of priority of February 14, 1916 and August 19, 1924.

The applicant herein proposes to transfer the right therefrom to a certain 2.4 acres in NW 1/4 SW 1/4, 4.1 acres in SW 1/4 SW 1/4, 3.5 acres in SE 1/4 SW 1/4, Section 26, Township 18 South, Range 46 East, WM; 3.0 acres in NE 1/4 SW 1/4, Section 26; 1.7 acres in SW 1/4 NW 1/4, 1.3 acres in SE I/4 NW 1/4, Section 28, Township 19 South, Range 46 East, WM; 4.0 acres in SE I/4 SE 1/4, Section 32, Township 20 South, Range 46 East, WM, being within Owyhee Irrigation District. The applicant further proposes to cancel supplemental irrigation rights from Snake River under Certificates 3297, 51346 and 24704 for said 20.0 acres in SW 1/4 NE 1/4, Section 5. The change in place of use is reported to be completed.

Frank W. Elfering, Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use is approved, without loss of priority.

It is FURTHER ORDERED that aforesaid portions of Certificate 3297, 51346 and 24704, for supplemental irrigation of 20.0 acres in SW 1/4 NE 1/4, Section 5, Township 18 South, Range 47 East, WM, are canceled.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of complete application of water to beneficial use on the lands to which the water is transferred hereby, the change of water right shall be considered perfected, and at a later date a certificate of water right shall be issued to United States of America, Bureau of Reclamation, confirming this and other changes within the District, and superseding Certificate 24707.
