ORDER CORRECTING A WATER RIGHT

AND APPROVING A CHANGE IN POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6796 submitted by

RICHARD C OR MARLA K. STEVENSON 3885 NW KENT LANE ROSEBURG, OREGON 97470.

The right to be modified, as evidenced by Certificate 22031, was perfected under Permit 20117 with a date of priority of FEBRUARY 15, 1951. The right allows the use of the NORTH UMPQUA RIVER, a tributary of UMPQUA RIVER, for IRRIGATION OF 6.55 ACRES. This right is limited to 0.08 cubic foot per second, if available at the authorized point of diversion: NW¼ SW¼, as projected within McKINNEY DLC 47, SECTION 23, T 26 S, R 6 W, WM, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

NW¼ SW¼ 6.55 ACRES as projected within McKINNEY DLC 47 SECTION 23
TOWNSHIP 26 SOUTH, RANGE 6 WEST, W.M.

The applicants and their Certified Water Right Examiner have provided evidence that the place of use is incorrectly described on Certificate 22031. The correct place of use is located as follows:

SW% NW% 1.02 ACRES NW% SW% 5.53 ACRES as projected within McKINNEY DLC 47 SECTION 23 TOWNSHIP 26 SOUTH, RANGE 6 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the point of diversion for the use of 0.01 CFS, on the following lands:

SW¼ NW¼ 0.42 ACRE
NW¼ SW¾ 0.57 ACRE
as projected within McKINNEY DLC 47
SECTION 23
TOWNSHIP 26 SOUTH, RANGE 6 WEST, W.M.

to the SW¼ NW¼, as projected within McKINNEY DLC 47, SECTION 23, T 26 S, R 6 W, WM; 2785 FEET NORTH AND 2460 FEET WEST FROM THE S¼ CORNER, SECTION 23.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1996.
- 2. The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available at the original point of diversion.
- 3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Certificate 22031 is cancelled. A new certificate, correcting the place of use, will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
