Authority

ORS 540.570 to 540.580 establishes the process in which a district may submit a request to transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

Findings of Fact

- 1. On November 22, 2013, Stanfield Irrigation District (SID) filed a district transfer application to permanently change the place of use under Certificates 86202, 86377, 86203, 74657, 76122 and 76137. The Department assigned the application number T-11693.
- 2. Certificate 86202 was superseded on May 2, 2011, by correcting Certificate 87035.
- 3. On February 19, 2014, amendments to the place of use listing and maps were received by the Department.
- 4. On March 4, 2014, the Department requested clarifications regarding the proposed place of
- 5. On March 26, 2014, the Department received the necessary clarifications allowing further processing of Transfer Application T-11693.
- 6. Notice of the application for transfer was published on December 3, 2013, pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notice.
- 7. On April 30, 2014, a Final Order recorded at Special Order Volume 92, Pages 318-324 was issued to approve transfer T-11693.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 8. On May 19, 2014, a Correcting Final Order recorded at Special Order Volume 92, Pages 534-535 was issued on to correct scrivener's errors in the Final Order issued April 30, 2014.
- 9. This order is issued to supersede both the Final Order recorded at Special Order Volume 92, Pages 318-324, and the Correcting Final Order recorded at Special Order Volume 92, Pages 534-535. This second correcting and superseding order is necessary to
 - a) correct scriveners errors in certain quarter-quarter and tax lot descriptions,
 - b) to show the correct association of a two parcels involved in the transfer (4.0 acre and 0.75 acre both located in the NE¼ NE¼, Section 11, Township 4 North, Range 29 East, W.M.) between Certificates 87035 and 86203 (primary irrigation), and
 - c) to transfer an additional 0.75 acres on Certificate 86377 (layered supplemental irrigation) inadvertently omitted from the order.
- 10. The corrections in Findings of Facts 11 16 & 20 22 appear in **bold**.

- 23. The district permanent transfer application satisfies the criteria of OAR 690-385-4000, contains the information required under OAR 690-385-2000, and includes maps meeting the requirements of OAR 690-385-2200.
- 24. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- 25. The proposed change in place of use would not result in enlargement of the rights.
- 26. The proposed changes in place of use would not result in injury to other rights.
- 27. All other application requirements have been met.

Conclusions of Law

The proposed change in place of use in Transfer Application T-11693 satisfies the requirements of ORS 540.574(3) and 540.580.

Now, therefore, it is ORDERED:

- 1. The orders entered at Volume 92, Pages 318-324, and Volume 92, Pages 534-535 are withdrawn and of no further force and effect and are superseded by this order.
- 2. The proposed changes contained in Transfer Application T-11693 are approved.
- 3. The right to the use of water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in the water rights and related decrees.
- 4. The former places of use shall no longer be irrigated as part of these water rights.
- 5. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2015. A Claim of beneficial Use shall be submitted by Stanfield Irrigation District to the Department within one year after the deadline for completion of the change and full beneficial use of the water.
- 6. Certificate 76122 is modified. No new superseding certificate will be issued because the transferred acres occurred within the same quarter-quarter.
- 7. Certificates 74657, 76137, 87035, 86377 and 86203 are modified. The Department will issue superseding certificates describing the rights when it is determined that it is necessary for record keeping.
