ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.523 after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 8368 submitted by

WILLIAM F. CORNELL IV

The right to be modified, as evidenced by a PORTION of Certificate 75802, was perfected under Permit G-10925 with a date of priority of APRIL 4, 1989. The right allows the use of a WELL, in the FORT ROCK BASIN, for IRRIGATION of 7.68 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.10 cubic foot per second, if available at the original well; SW $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 5, T 27 S, R 16 E, WM; 1320 FEET NORTH AND 1320 FEET EAST FROM THE SW CORNER, SECTION 5, or its equivalent in case of rotation, measured at the well.

This is an order in other than a contested case. This order is subject to judicial review under 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

SW $\frac{1}{4}$  SW $\frac{1}{4}$  7.68 ACRES  
SECTION 5  
TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the place of use to:

SE $\frac{1}{4}$  SW $\frac{1}{4}$  7.68 ACRES  
SECTION 5  
TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

THIS TEMPORARY CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The change is temporary. The change shall be effective upon issuance of this order.
2. The former place of use shall not be irrigated as part of this water right during the 2000, 2001, 2002, 2003, and 2004 irrigation seasons, unless the water user requests the temporary be rescinded sooner.

3. The use shall revert to the authorized place of use at the end of the 2004 irrigation season, unless the water user requests the temporary be rescinded sooner.
4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
5. The use of the remaining water right described by Certificate 75802 shall continue to be in accordance with the terms and conditions of Certificate 75802.
