Findings of Fact

- 1. On February 3, 20212, Columbia Improvement District filed a district transfer application to temporarily change the places of use within the boundaries of the irrigation district under Certificates 92990, 92991, 92992, 92993, and 95154. The Department assigned the application number T-13608.
- 2. Notice of the application for transfer was published on February 16, 2021, pursuant to ORS 540.570 and OAR 690-385-3400. No comments were filed in response to the notice.

- 22. A portion of the proposed place of use described in Finding of Fact #21, above, will become layered with irrigation under Permits S-51017, S-54675, and G-17354. These permits are not involved in this transfer. The applicant has stated that the irrigation under Permits S-51017, S-54675, and G-17354 will remain unexercised at this location during the term of this temporary transfer.
- 23. As a condition of this Transfer T-13608, the portions of Permit S-51017, S-54675, and G-17354 that are appurtenant to the proposed places of use as described in Finding of Fact #21, above, shall remain unexercised during the term of this temporary transfer.
- 24. Certain portions of the authorized and proposed places of use as described in Findings of Facts #3, 4, 9, 10, 13, 14, 19, 20, and 21, above, are appurtenant to lands described under Permits S-55061, S-54633, S-55190, and S-55192. These permits are for use of water from the Columbia River, tributary to the Pacific Ocean. The applicant has stated that these permits will not be exercised on any parcels associated with this transfer during the regular 2021 irrigation season. Therefore, the authorized places of use under described in Findings of Facts #3, 4, 9, 10, 13, 14, 19, 20, and 21, above, are not subject to conditions set forth in Permits S-55061, S-54633, S-55190, and S-55192.



- 25. The district temporary transfer application satisfies the criteria of ORS 540.570 and OAR 690-385-3000, contains the information required under OAR 690-385-3200, and includes a map meeting the requirements of OAR 690-385-3300.
- 26. Water has been used within the last five years according to the terms and conditions of the rights. There is no evidence available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 27. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- 28. Diversion structures, district canals, wells, pumps, pump stations, ditches, pipeline, and sprinkler systems sufficient to use the full amount of water allowed under the existing rights is present.
- 29. The proposed changes in place of use, as conditioned, will not result in enlargement of the rights as defined in OAR 690-385-0100(6).
- 30. The proposed changes in place of use, as conditioned would not result in injury to other water rights as defined in OAR 690-385-0100(4).
- 31. All other applicable requirements for district temporary water right transfers are met.

Conclusions of Law

The temporary changes in places of use proposed in Temporary Transfer Application T-13608, as conditioned above, are consistent with the requirements of ORS 540.570 and OAR 690-385-3500.

Now, therefore, it is ORDERED:

- 1. The temporary changes in place of use as proposed in Transfer Application T-13608, as conditioned above, are approved.
- 2. The former places of use **shall not** be irrigated as part of these water rights during the 2021 irrigation season.
- The use shall revert to the authorized place of use at the end of the 2021 irrigation season.
- 4. The portion of Certificate 44654 that is appurtenant to the proposed place of use as described in Finding of Fact #4, above, shall remain unexercised during the term of this temporary transfer.
- 5. The portions of Permits G-17354, S-51017, and S-54675 that are appurtenant to the proposed places of use as described in Findings of Facts 4, 10, 14, and 21, above, shall remain unexercised during the term of this temporary transfer.
- 6. Any application for permanent transfer of Certificates 92990, 92991, 92992, 92993, and 95154, shall be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380. Approval of this temporary transfer does

not establish a precedent for approval of a subsequent application filed for a permanent transfer.

- 7. The time during which water is used on the proposed lands under this approved temporary transfer does not apply toward a finding of forfeiture of Certificates 92990, 92991, 92992, 92993, and 95154, under ORS 540.610.
- 8. The use of water on lands from which the right is transferred and in the new temporary location during the same irrigation season or calendar year is prohibited and may subject the district and the landowner to civil penalties.
- 9. The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.
- 10. The use of water under this temporary transfer may be conditioned or revoked at any time to the extent necessary to avoid injury if the Department finds the transfer causes injury to any existing water right.
- 11. The use of water at the temporary place of use authorized by this transfer shall be in accordance with the terms and conditions of Certificates 92990, 92991, 92992, 92993, and 95154.
- 12. The use of the remaining water right described by Certificates 92990, 92991, 92992, 92993, and 95154, shall continue to be in accordance with the terms and conditions Certificates 92990, 92991, 92992, 92993, and 95154.
