On March 11, 1969, Irene Wadsworth and on March 24, 1969, K. D. and Jessie G. Coomler submitted affidavits that they are the owners of described lands and the water rights appurtenant thereto, that they have abandoned any and all interest in and to said water rights and request the same be canceled.

The water rights in question are:

- (a) for the use of not to exceed 0.19 cubic foot per second of the waters of Little Pudding River for irrigation of 15.13 acres in  $SW_4^1$   $SW_4^1$ , Section 14, Township 6 South, Range 2 West, W.M., with a priority of June 17, 1924, and is evidenced by certificate of water right issued in the name of E. A. & J. O. Hayes and recorded at page 7780, Volume 7, State Record of Water Right Certificates;
- (b) for the use of not to exceed 0.26 cubic foot per second of the Drainage water from Lake Labish Bed and other lands for supplemental irrigation of 18.4 acres in Lot 13 (NW4 SW4 & SW4 SW4), and 2.6 acres in Lot 5 (SW4 SW4 & SE4 SW4), Section 14, Township 6 South, Range 2 West, W.M., with a date of priority of April 8, 1941, and is evidenced by certificate of water right issued in the name of Hayes Labish Farm and recorded at page 35278, Volume 27, State Record of Water Right Certificates.

That part of the water right described in the preceding paragraph for the use of not to exceed 0.56 cubic foot per second of the Drainage water from Lake Labish Bed and other lands for supplemental irrigation of:

ORS 540.621 provides that: "Whenever the owner of a perfected and developed water right certifies under oath to the State Engineer that the water right has been abandoned by him and that he desires cancellation thereof, the State Engineer shall enter an order canceling the water right."

NOW, THEREFORE, it is hereby ORDERED that the right for the use of not to exceed 0.19 cubic foot per second of the waters of Little Pudding River for irrigation of 15.13 acres in  $SW_4^1$   $SW_4^1$ , Section 14, Township 6 South, Range 2 West, W.M., with a date of priority of June 17, 1924, as evidenced by certificate of water right recorded at page 7780, Volume 7, State Record of Water Right Certificates, is canceled.

It is FURTHER ORDERED that the right for the use of not to exceed 0.26 cubic foot per second of the Drainage water from Lake Labish Bed and other lands for supplemental irrigation of 18.4 acres in Lot 13 ( $NW_{4}^{1}$   $SW_{4}^{1}$  &  $SW_{4}^{1}$   $SW_{4}^{1}$ ) and 2.6 acres in Lot 5 ( $SW_{4}^{1}$   $SW_{4}^{1}$  &  $SE_{4}^{1}$   $SW_{4}^{1}$ ). Section 14, Township 6 South, Range 2 West, W.M., with a date of priority of April 8, 1941, is canceled.

It is FURTHER ORDERED that certificate of water right recorded at page 35278. Volume 27, State Record of Water Right Certificates, is canceled, and in lieu thereof a certificate be issued in the name of Hayes Labish Farms covering that part of the water right not in question which is for the use of not to exceed 0.56 cubic foot per second of the Drainage water from Lake Labish Bed and other lands for supplemental irrigation of:
