## Authority

Oregon Revised Statue (ORS) 540.570 establishes the process in which a district may submit a request to temporarily transfer a water right within district boundaries. Oregon Administrative Rule (OAR) Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

# **Applicant**

SUTHERLIN WATER CONTROL DISTRICT 495 N. STATE ST SUTHERLIN, OR 97479

### Findings of Fact

- 1. On March 26, 2018, Sutherlin Water Control District filed an application to temporarily change the place of use and point of diversion to serve the proposed place of use under Certificates 76599 and 76600. The Department assigned the application number T-12881.
- 2. On March 26, 2018, the Department contacted the applicant with regard to miscalculated fees.
- On April 9, 2018, the Department received additional fees completing the application.
- Notice of the application for transfer was published on April 3, 2018, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Limit/Duty: The amount of water used for irrigation, together with the amount secured

under any other right existing for the same lands, is limited to ONE-

EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each

year from direct flow and storage. The use of water for supplemental

irrigation is limited to stored water only.

### Temporary Transfer Review Criteria

- 13. Water has been used within the last five years according to the terms and conditions of the rights. There is no evidence available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 14. A diversion structure and ditch sufficient to use the full amount of water allowed under the existing rights are present.
- 15. The proposed changes as conditioned would not result in enlargement of the rights.
- 16. The proposed changes as conditioned would not result in injury to other water rights. This finding is made through an abbreviated review recognizing that the transfer may be revoked under ORS 540.523(5) if the Department later finds that the transfer is causing injury to any existing water right.

#### Conclusions of Law

The temporary changes in place of use and additional point of diversion to convey water to the temporary place of use proposed in application Temporary Transfer Application T-12881 are consistent with the requirements of ORS 540.570 and OAR 690-385-8000.

# Now, therefore, it is ORDERED:

- The temporary changes in place of use and additional point of diversion to convey water to the temporary place of use proposed in Temporary Transfer Application T-12881 are approved.
- 2. The former place of use **shall not** be irrigated as part of these water rights during the 2018 irrigation season.
- 3. The use shall revert to the authorized place of use at the end of the 2018 irrigation season. The authorization to use the additional point of diversion shall be terminated concurrently.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the changes causes injury to any existing water right.
- 5. A subsequent application for permanent transfer of Certificates 76599 and 76600 shall be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380. Approval of this temporary transfer does not establish a precedent for approval of a subsequent application filed for a permanent transfer.
- 6. The use of water at the temporary place of use authorized by this transfer shall be in accordance with the terms and conditions of Certificates 76599 and 76600.
- 7. The time during which water is used under this approved temporary transfer does not apply toward a finding of forfeiture under ORS 540.610.
- 8. Water use measurement conditions:
  - a. **Before water use may begin** under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each new point of diversion.
  - b. The water user shall maintain the meters or measuring devices in good working order.
  - c. The water user shall allow the Watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the Watermaster shall request access upon reasonable notice.
