ORDER

On February 24, 1972, Robert Hedges acting for Willamette Factors, Inc., submitted an affidavit that they are the owners of a water right and the lands to which the right is appurtenant; that they have abandoned any and all interest in and to the said water right and request the same be canceled.

The water right in question is part of that evidenced by certificate recorded at Page 20548, Volume 15, State Record of Water Right Certificates, and is for the appropriation of not to exceed 0.32 cubic foot per second of water from Willamette River with a priority date of November 10, 1950, for the irrigation of 0.8 acre in SE¼ SW¼, 24.2 acres in SW¼ SE¼, and 0.7 acre in SE¼ SE¼ of Section 24, Township 3 South, Range 1 West, W. M.

That part of the water right evidenced by said certificate for the appropriation of not to exceed 1.62 cubic foot per second of water from Willamette River for the irrigation of 0.8 acre in SE¼ SW¼, 15.8 acres in SW¼ SE¼, 19.3 acres in SE¼ SE¼ of Section 24, 20.0 acres in NE¼ NE¼, 40.0 acres in NW¼ NE¼, 20.0 acres in SW¼ NE¼, 10.0 acres in SE¼ NE¼, 2.3 acres in NE¼ NW¼, 1.3 acres in SE¼ NW¼ of Section 25, Township 3 South, Range 1 West, W. M. is not in question in this proceeding.

ORS 540.621 provides that: "Whenever the owner of a perfected and developed water right certifies under oath to the Water Resources Director that the water right has been abandoned by him and that he desires cancellation thereof, the Water Resources Director shall enter an order canceling the water right."

NOW, THEREFORE, it hereby is ORDERED that the water right for the use of 0.32 cubic foot per second of water from Willamette River, with a priority date of November 10, 1950, for the irrigation of 0.8 acre in SE4 SW4, 24.2 acres in SW4 SE4, and 0.7 acre in SE4 SE4 of Section 24, Township 3 South, Range 1 West, W. M., is canceled.

It is FURTHER ORDERED that the certificate of water right recorded at Page 20548, Volume 15, State Record of Water Right Certificates is canceled, and in lieu thereof a new certificate be issued to C. E. Gordon covering that part of the water right not in question herein.
