## ORDER APPROVING AND DENYING ALTERNATE ACREAGE PETITIONS

Tumalo Irrigation District filed petitions in accordance with the provisions of ORS 540.570 to use water described by Water Right Certificates 26508 and 31410 on alternate acreage.

A written review indicates that approval of some of the petitions would not cause injury to other water rights or expansion of the water rights involved. These petitions may be approved.

Engelage to Schlueter, 5.0 acres under certificate 26508, from the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 26, T 16 S, R 11 E, WM, to the NE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 35, T 16 S, R 11 E, WM.

Engelage to Muzzy, 5.0 acres under 26508, from the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 26, T 16 S, R 11 E, WM, to the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 14, T 16 S, R 11 E, WM.

Muzzy to Muzzy, 1.0 acre under certificate 31410, from the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 23, T 16 S, R 11 E, WM, to the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 14, T 16 S, R 11 E, WM.

Coats to Coats, 0.5 acre under certificate 26508, from the SW  $\frac{1}{4}$  NE  $\frac{1}{4}$ , Section 13, T 17 S, R 11 E, WM, to the SE  $\frac{1}{4}$  SEction 11, T 17 S, R 11 E, WM.

The Alternate Acreage Petitions listed above for Water Right Certificates 26508 and 31410 are APPROVED.

The approval of these petitions does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

A written review indicates that approval of other of the petitions would cause injury to other water rights and possible expansion of the water rights involved. These petitions should be denied.

LaVeau to Schlueter, 3.4 acres under certificate 26508, as modified by water right transfer 6154, from the NE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 18, T 16 S, R 12 E, WM.

LaVeau to Miller, 2.0 acres under certificate 26508, as modified by water right transfer 6154, from the NE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 18, T 16 S, R 12 E, WM.

Coats to Coats, 1.5 acres under certificate 31410, from the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 13, T 17 S, R 11 E, WM.

The Alternate Acreage Petitions listed above for Water Right Certificates 26508 and 31410 are DENIED.

Tumalo Irrigation District may file a petition for reconsideration within thirty days of the date of this order. The petition for reconsideration must set forth specific grounds for reconsideration. The petition for reconsideration may include a request for a contested case hearing.
