## ORDER APPROVING AN ADDITIONAL POINT OF APPROPRIATION

Pursuant to ORS 537.211, after notice was given and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, PERMIT AMENDMENT T-7459 submitted by

OREGON FLOWERS, INC. P.O. 311 AURORA, OREGON 97002.

The water use permit to be modified is Permit G-11247 with a date of priority of DECEMBER 10, 1990. The permit allows the use of A WELL, in the MILL CREEK BASIN, for NURSERY OPERATIONS FOR 27.6 ACRES. The amount of water to which this permit is entitled is limited to an amount actually beneficially used and shall not exceed 500 GALLONS PER MINUTE, if available at the original well; NW¼ SW¼, SECTION 13, T 4 S, R 1 W, WM; 1520 FEET NORTH AND 10 FEET EAST FROM THE SW CORNER, SECTION 13, or its equivalent in case of rotation, measured at the well.

The amount of water used for NURSERY OPERATIONS is limited to a diversion of 0.15 cubic foot per second per acre. For the irrigation of containerized nursery plants, the amount of water diverted is limited to ONE-FORTIETH of one cubic foot per second (or its equivalent) and 5.0 acre feet per acre per year. For irrigation of in ground nursery plants the amount of water diverted is limited to ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2½ acre feet per acre per year. The use of water for NURSERY OPERATIONS may be made at anytime of the year that use is beneficial. For the irrigation of any other crop, the amount of water diverted is limited to ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2½ acre feet per acre during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

- All other terms and conditions of the permit remain the same.
- Water shall be acquired from the same aquifer as the 2. original point of appropriation.
