On July 24, 1962, the Marion County Investment Company of Mill City, Oregon, file! an application in the office of the State Engineer for the approval of a change in use, place of use and point of diversion of water from North Santiam River, pursuant to the provisions of ORS 540.510 to 540.530.

By decree of the Circuit Court for Marion County, Oregon, entered January 30, 1945, In the Matter of the Determination of the Relative Rights to the Use of the Waters of North Santiam River and its Tributaries, a water right was established in the name of A. D. Gardner for the use of 812 cubic feet per second of the waters of North Santiam River for power and other manufacturing purposes in Section 10, Township 9 South, Range 1 West, W.M., with a date of priority of 1866, through the Gardner ditch. The water is diverted into this canal from the north channel of the North Santiam River at a point located 500 feet North and 2600 feet West from the southeast corner of Section 11, and being within the SW½ SE½, said Section 11, Township 9 South, Range 1 West, W. M.

The Marion County Investment Company proposes to change the use of 50 cubic feet per second from power and other manufacturing purposes to that of municipal purposes within the following described area:

and to convey the water for said purposes by means of two new diversions to be located as follows: (1) 620 feet South and 120 feet West from the north-east corner of the SW½ NE½, and being within the SW½ NE½, Section 13, Township 9 South, Range 1 West, W. M., and (2) 830 feet South and 660 feet East from the N½ corner of Section 13, and being within the NW½ NE½, said Section 13, Township 9 South, Range 1 West, W. M.

Notice of the filing of the application was given by publication setting forth a time and place certain for hearing objections to the proposed change in use, place of use and point of diversion of water, if any there were, namely: at the office of the State Engineer, Salem, Oregon, on September 26, 1962, at 9:30 o'clock a.m. The notice was published in The Stayron Mail, a newspaper printed and having general circulation in Marion County, Oregon, for a period of three weeks in the issues of August 2, 9 and 16, 1962. The date set for hearing in said notice was not less than thirty days after the last publication of the notice.

No objections having been filed and it appearing that the proposed change in use, place of use and point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in use and place of use of water be and the same is hereby approved, and that the water right for the use of 50 cubic feet per second of water from North Gantiam River for power and other manufacturing purposes hereinbefore described as appurtenant to Section 10, Township 9 South, Range 1 West, W. M., with a date of priority of 1866, be severed therefrom and simultaneously and without loss of priority transferred to the following described area for municipal purposes.

It is FURTHER ORDERED that the proposed change in point of diversion of water from North Santiam River, to-wit:

From a point located 500 feet North and 2600 feet West from the southeast corner of Section 11, and being within the SW2 SE2, said Section 11, Township 9 South, Range 1 West, W.M.

To a point to be located 620 feet South and 120 feet West from the northeast corner of the SW NEZ, Section 13, and being within the SWZ NEZ, said Section 13; and

To a point to be located 830 feet South and 660 feet East from the N_{χ}^{1} corner of Section 13, and being within the NW χ NE χ , said Section 13, Township 9 South, Range 1 West, W. M.

for municipal purposes within the area hereinbefore described, with a date of priority of 1866, be and the same is hereby approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1975, or within such extension of time as may be granted by the State Engineer for good cause shown.

It is FURTHER ORDERED that certificate of water right heretofore issued to A. D. Gardner and recorded at page 14882, Volume 12, State Record of Water Right Certificates, be and the same hereby is canceled and in lieu thereof a new certificate be issued to Marion County Investment Company covering the portion of the water right not involved in this proceeding, and upon receipt of proof satisfactory to the State Engineer of application of water to beneficial use, a certificate of water right shall be issued to City of Salem, to the extent to which the water has been applied beneficially.
