ORDER APPROVING A HISTORICAL CHANGE IN POINT OF DIVERSION

Pursuant to ORS 540.532, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8278 submitted by

GORDON AND CHRISTINE WELLS 268 PICKETT CREEK ROAD GRANTS PASS, OREGON 97527.

The right to be modified, as evidenced by a portion of Certificate 21013, was perfected under Permit 21155 with a date of priority of MARCH 4, 1952. The right allows the use of PICKETT CREEK, a tributary of the ROGUE RIVER, for IRRIGATION of 1.75 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.022 cubic foot per second, if available at the authorized point of diversion: SW% NE%, SECTION 26, T 35 S, R 7 W, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SW% NE% 1.75 ACRES
SECTION 26
TOWNSHIP 35 SOUTH, RANGE 7 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The point of diversion was changed over ten years ago to:

SW% NE% SECTION 26, T 35 S, R 7 W, W.M.; 500 FEET EAST AND 720 FEET NORTH FROM THE CENTER OF SECTION 26.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.

- 2. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 3. Water shall be acquired from the same surface water source as the original point of diversion.
- 4. Prior to further diversion of water, the water user shall install and maintain a fish screen or fish by-pass device. The type and plans of the screen or by-pass device must be approved by the Oregon Department of Fish and Wildlife prior to beginning of construction and shall be installed under the supervision of the Department of Fish and Wildlife.

The water user may participate in the Oregon Department of Fish and Wildlife's cost sharing program for installation of screening and by-pass devices in accordance with ORS 540.525.

Certificate 21013 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. A new certificate confirming this water right will also be issued.
