- 2. The former place of use shall no longer be irrigated as a part of these water rights.
- 3. Proof, to the satisfaction of the Director, that the changes approved by this order have been completed must be submitted by STANFIELD IRRIGATION DISTRICT on or before October 1, 2002.
- 4. Except as modified herein, all other conditions and restrictions of Certificate 74662 and Permit 7400 remain in effect.
- 5. When the Director determines that it is necessary, or to facilitate records keeping, new certificates will be issued to confirm all completed changes for which satisfactory proof has been made and to confirm that portion of the right not modified by this or any other order.
