## EEFORE THE WATER RESOURCES DIRECTOR OF OREGON Marion County

IN THE MATTER OF THE CANCELATION OF A GROUND WATER REGISTRATION CLAIMED RIGHT IN THE NAME OF FRED VIESKO

ORDER

On November 25, 1975, A. Eugene Petroff and Leo S. Meysing, partners in Davis Street Investment Company, submitted an affidavit that they are the legal owners of lands claimed to have been irrigated as described in certificate of registration recorded at Page GR 439-L, Volume 3, Ground Water Registration Record; that they have abandoned said claim of water right and request the same be canceled.

The claimed right in question is for the use of not to exceed 152.6 gallons per minute from a well located 14.8 feet South and 2181.3 feet East from the most northerly Northeast corner of Wm. Matheny D.L.C. #76, being within the NE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 35, Township 5 South, Range 3 West, W.M., for the irrigation of 1.62 acres in SE $\frac{1}{4}$  NW $\frac{1}{4}$ , 18.20 acres in NE $\frac{1}{4}$  SW $\frac{1}{4}$ , 21.30 acres in SE $\frac{1}{4}$  SW $\frac{1}{4}$ , 0.70 acre in SW $\frac{1}{4}$  SW $\frac{1}{4}$  and 7.53 acres in NW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 35, Township 5 South, (erroneously described in the certificate of registration as Township 6 South) Range 3 West, W.M.

NOW, THEREFORE, it hereby is ORDERED that the claim of a water right for the use of not to exceed 152.6 gallons per minute from a well located 14.8 feet South and 2181.3 feet East from the most northerly Northeast corner of Wm. Matheny D.L.C. #76, being within the NE<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub>, Section 35, Township 5 South, Range 3 West, V.M., for the irrigation of 1.62 acres in SE<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub>, 18.20 acres in NE<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub>, 21.30 acres in SE<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub>, 0.70 acre in SW<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub> and 7.53 acres in NW<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>, Section 35, Township 5 South, Range 3 West, W.M., is canceled.
