IN THE MATTER OF THE CANCELATION OF A WATER RIGHT IN THE NAME OF THREE MILE IRRIGATION COOPERATIVE, INC.

ORDER

On September 22, 1975, Jerry O. Booth submitted an affidavit that he is the owner of Lots 32, 33 and 34 of Riverview Addition in Wasco County to which a water right is appurtenant; that he has abandoned any and all interest in and to said water right and request the same to be canceled.

The water right in question is for the use of not to exceed 0.093 cubic foot per second of the waters from a well for the irrigation of 5.6 acres in the NE¹/₄ SW¹/₄, Section 1, Township 1 North, Range 13 East, W.M., with a date of priority of December 12, 1945, and is evidenced by certificate of water right recorded at Page 20792, Volume 15, State Record of Water Right Certificates.

That part of the water right evidenced by said certificate for the appropriation of not to exceed 3.017 cubic feet per second of the waters of a well for irrigation of 181.02 acres as follows:

ORS 540.621 provides: "Whenever the owner of a perfected and developed water right certifies under oath to the Water Resources Director that the water right has been abandoned by him and that he desires cancelation thereof, the Water Resources Director shall enter an order canceling the water right."

NOW, THEREFORE, it hereby is ORDERED that the right for the use of not to exceed 0.093 cubic foot per second of the waters of a well for the irrigation of 5.6 acres in the NE4 SW4, Section 1, as projected within W.C. Laughton D.L.C. #38, Township 1 North, Range 13 East, W.M., with a date of priority of December 12, 1945, is canceled.
