ORDER

On December 9, 1963, Andrew C. Thomson and Marjorie C. Thomson submitted a sworn statement that they are the legal owners of a certain water right and the real property to which the right is appurtenant; that they have abandoned any and all interest in and to the said water right and request the same to be canceled.

The water right in question is a part of that evidenced by the certificate recorded at Volume 19, page 26824, State Record of Water Rights Certificates, and is for the appropriation of not to exceed 0.64 cubic foot per second of water from a well (¿cavel pit), with a date of priority of October 14, 1958, for irrigation of the following land:

12.8 acres NE% SE%
0.8 acre NW% SE%
11.4 acres SW% SE%
34.9 acres SE% SE%, Section 15,
Township 15 South, Range 5 West, W.M.

That part of the water right evidenced by said certificate for the appropriation of not to exceed 0.70 cubic foot per second of water from a well (gravel pit), with a date of priority of October 14, 1958, for irrigation of the following land:

19.3 acres NEW NEW 15.0 acres SEW NEW, Section 22

9.7 acres NW/A NW/A 12.0 acres SW/A NW/A, Section 23, Township 15 South, Range 5 West, W.M.,

is not in question.

ORS 540.621 provides that: "Whenever the owner of a perfected and developed water right certifies under oath to the State Engineer that

the water right has been abandoned by him and that he desires cancelation thereof, the State Engineer shall enter an order canceling the water right".

NOW, THEREFORE, it hereby is ORDERED that the right for the use of not to exceed 0.64 cubic foot per second of water from a well (gravel pit), with a date of priority of October 14, 1958, for irrigation of the following land:

12.8 acres NEW SEW
0.8 acre NWW SEW
11.4 acres SWW SEW
34.9 acres SEW SEW, Section 15,
Township 15 South, Range 5 West, W.M.,

is canceled.

It is FURTHER ORDERED that the certificate recorded at Volume 19, page 26824, State Record of Water Rights Certificates, is canceled and in lieu thereof a certificate be issued in the name of Robert Harper for the appropriation of not to exceed 0.70 cubic foot per second of water from a well (gravel pit), with a date of priority of October 14, 1958, for irrigation of the following land:

19.3 acres NEW NEW 15.0 acres SEW NEW, Section 22

9.7 acres NW/4 NW/4 12.0 acres SW/4 NW/4, Section 23, Township 15 South, Range 5 West, W.M.
