ORDER APPROVING AN ADDITIONAL POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7863 submitted by

STATE OF OREGON - DEPARTMENT OF ADMINISTRATIVE SERVICES ADMINISTRATOR - FACILITIES DIVISION 1225 FERRY STREET SE. SALEM, OREGON 97310.

The right to be modified was perfected under Permit G-11403 with a date of priority of JUNE 18, 1991. The right allows the use of A WELL, in the MILL CREEK BASIN, for IRRIGATION OF 29.45 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.368 cubic foot per second, if available at the original well; NW¼ NW¼, SECTION 26, T 7 S, R 3 W, W.M.; 110 FEET SOUTH AND 50 FEET EAST FROM THE NW CORNER OF SECTION 26, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

Proof to the satisfaction of the Department has been received that the appropriation was perfected under Permit G-11403.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 2000.
- 2. The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.

- 3. The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original point of appropriation.

When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
