Jerry N. Hilger, Gary and Alice Teague, Linda Lance, G.L. and Gwen Scott, Dorothy H. Berry, Robert and Eleanor Burton, Jakob Jauker, Dora M. Baines, John W. and Irene E. Loper and the Oregon Water Trust submitted a conserved water application and associated change in the point of diversion dated September 1, 1998. The Department issued an order approving the allocation of conserved water for Certificates 32772, 68497, 76182, and approving the associated change in the point of diversion for Certificate 49039 on June 10, 1999. The order was filed as Special Order Volume 53, pages 870-873.

Subsequent to issuance of the order, the Department has identified clerical errors in the assignment of irrigated acreage, the rates and duties, and priority dates of the associated rights established under the order.

The following information summarizes the results of the conserved water project. For each certificate involved in the application, a summary by quarter quarter section describes what acreage is part of the conserved water application, what acreage is not part of it, and what acreage will be canceled. A table then describes the irrigated acreage by landowner, the rate before and after the conserved water application, and the instream contribution.

(Special Order Volume 53, p. 870 listed Certificate 49038 as part of the Conserved Water Application. This was a clerical error and should not have been included. Certificate 76182 was erroneously omitted from Special Order Volume 53, p. 870.)

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-001-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

- 1. Certificate 32772 is hereby canceled. (No significant changes from Special Order Vol. 53, page 872.)
- 2. The Department shall issue a superseding Certificate with a priority date of 1896 for diversion and use of 0.062 cfs, from Evans Creek, for domestic, stock and irrigation of 4.96 acres, at a reduced rate of 1/80 cfs/acre, all lands lying north of Evans Creek, as follows:

The Department shall cancel 4.00 acres of water rights.

(Duty limitation which was not on the original water right, but was included in Special Order Vol. 53, page 872 was dropped, the rate was changed and the issuance of a remaining right certificate for 4.04 acres is added. Five certificates for conserved water, with different points of diversion, shall be issued instead of one certificate.)

- 3. It is further ordered that Certificate 68497 is hereby canceled. (No significant changes from Special Order Vol. 53, page 872.)
- 4. The Department shall issue a superseding Certificate with a priority date of 1896 for diversion and use of 0.025 cfs from Evans Creek, for irrigation of 2.01 acres, domestic, and stock use at a reduced rate of 1/80 cfs/acres, all lands lying north of Evans Creek, as follows:

8. It is further ordered that Certificate 49039 be canceled and a superseding certificate with a priority date of May 15, 1975, be issued showing the new point of diversion from Evans Creek as follows:

NW¼ NW¼, SECTION 12, TOWNSHIP 35 SOUTH, RANGE 4 WEST, W.M.; SOUTH 38 DEGREES 13 MINUTES EAST 1405 FEET FROM THE NW CORNER, SECTION 12.

The new certificate allows the diversion and use of 0.018 cfs, not to exceed 4.5 acre feet per acre, for irrigation of 1.5 acres at a rate of 1/80 cfs/acre, all lands lying north of Evans Creek as follows:

### NW¼ NW¼ 1.5 ACRES SECTION 12 TOWNSHIP 35 SOUTH, RANGE 4 WEST, W.M.

The Department shall cancel 0.20 acres of water rights.

(Priority date, acreage, point of diversion and legal description amended from Special Order Vol. 53, page 873.)

9. The Department shall issue a Certificate for an instream water right for the State's portion of the water conserved under this application, with a priority date of 1896 plus one minute for use of 0.152 cfs, to an instream water right beginning at their respective points of diversion and ending at river mile 8 (Wimer Bridge) on Evans Creek. The instream rights portions come from the following certificates:

The conserved water will be combined with the existing instream right for 0.055 cfs at this location, established under a related conservation project (Conserved Water Application # 1) completed in 1996 and evidenced by the Order recorded at Special Order Volume 50, page 853, with a priority date of 1896 plus one minute. The instream rights portions come from the following certificates:

Certificate 72139 0.025 cfs Certificate 72140 0.030 cfs

Within the designated reaches of these rights, this total instream right of 0.207 cfs shall replace a portion of the existing instream water right for Evans Creek, evidenced by Certificate 73027, during the period from April 1 to October 31, of each year.

(Duty limitation which was not on the original water right, but was included in Special Order Vol. 53, page 873 was dropped; the rate and legal description were amended, clarifies that the right is not additive to the existing instream right.)
