O R D E R

On January 27, 1972, Andrew and Dorothy Popson submitted an affidavit that they are the owners of a water right and the lands to which the right is appurtenant; that they have abandoned any and all interest in and to said water right and request the same be canceled.

The water right in question is part of that evidenced by certificate recorded at Page 7825, Volume 8, State Record of Water Right Certificates, and is for the appropriation of not to exceed 0.17 cubic foot per second of water from Anna Creek, with a priority date of June 25, 1927, for irrigation of 13.6 acres in the SE $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 13, Township 33 South, Range 6 East, W.M.


That part of the water right evidenced by said certificate for the appropriation of not to exceed 2.74 cubic feet per second of water from Anna Creek for irrigation of 20.0 acres in NE $\frac{1}{4}$  NE $\frac{1}{4}$ , 20.0 acres in SE $\frac{1}{4}$  NE $\frac{1}{4}$ , 20.0 acres in NE $\frac{1}{4}$  SE $\frac{1}{4}$ , 4.5 acres in SE $\frac{1}{4}$  SE $\frac{1}{4}$ , 31.0 acres in SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 1, 10.0 acres in NW $\frac{1}{4}$  SW $\frac{1}{4}$ , 20.0 acres in SW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 12, 40.0 acres in NW $\frac{1}{4}$  NW $\frac{1}{4}$ , 12.0 acres in SE $\frac{1}{4}$  NW $\frac{1}{4}$ , 30.0 acres in SE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 13, Township 33 South, Range 6 East, W.M., and 12.0 acres in SW $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 6, Township 33 South, Range 7 $\frac{1}{2}$  East, W.M., is not in question in this proceeding.

ORS 540.621 provides that: "Whenever the owner of a perfected and developed water right certifies under oath to the Water Resources Director that the water right has been abandoned by him and that he desires cancellation thereof, the Water Resources Director shall enter an order canceling the water right."

NOW, THEREFORE, it hereby is ORDERED that the water right for the use of 0.17 cubic foot per second of water from Anna Creek, with a priority date of June 25, 1927, for irrigation of 13.6 acres in the SE $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 13, Township 33 South, Range 6 East, W.M., is canceled.

It is FURTHER ORDERED that the certificate of water right recorded at Page 7825, Volume 8, State Record of Water Right Certificates is canceled, and in lieu thereof a new certificate be issued to R.S. Dixon covering that part of the water right not in question herein.
