ORDER APPROVING A CHANGE IN POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6544 submitted by

STATE OF OREGON, acting by and through the STATE BOARD OF EDUCATION, on behalf of OREGON STATE UNIVERSITY P.O. BOX 396 CORVALLIS, OREGON 97339.

The right to be modified, as evidenced by Certificate 43479, was perfected under Permit G-2975 with a date of priority of JULY 14, 1965. The right allows the use of A WELL, a tributary of the WILLAMETTE RIVER, for IRRIGATION OF 37.4 ACRES. The right is limited to 0.47 cubic foot per second, if available at the original well; $SW^{\frac{1}{4}}$, $NW^{\frac{1}{4}}$, as projected within MOORE DLC 66, SECTION 36, T 11 S, R 5 W, WM; 3410 FEET NORTH AND 2400 FEET WEST FROM THE SW CORNER, LOT 6 ($SW^{\frac{1}{4}}$ $SE^{\frac{1}{4}}$), SECTION 36, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and $2\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

SE¼ NE¼ 4.4 ACRES
NE¾ SE¼ 0.8 ACRE
both as projected within MOORE DLC 66
SECTION 35

NW¼ NW¼ 3.4 ACRES
SW¼ NW¼ 2.6 ACRES
both as projected within EARL DLC 67
SW¼ NW¼ 26.2 ACRES
as projected within MOORE DLC 66
SECTION 36
TOWNSHIP 11 SOUTH, RANGE 5 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the points of appropriation to:

NE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within EARL DLC 67, SW $\frac{1}{4}$ NW $\frac{1}{4}$, and NW $\frac{1}{4}$ SW $\frac{1}{4}$, both as projected within MOORE DLC 66, SECTION 36, T 11 S, R 5 W, WM; WELL 4 - 3950 FEET NORTH AND 2144 FEET WEST, WELL 2 - 3002 FEET NORTH AND 2573 FEET WEST, and WELL 3 - 1368 FEET NORTH AND 3320 FEET WEST FROM THE NW CORNER, ROBNETT DLC 60.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1995.
- 2. The quantity of water diverted at the new points of appropriation (wells) shall not exceed the quantity of water available from the original point of appropriation.
- 3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 43479 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
