IN THE MA'TER OF THE APP'ICATION OF GUY E. SKAGGS FOR APPROVAL OF A CHANGE IN PLACE OF USE OF WATER TROM SILVER CREEK.

## ORDER APPROVING APPLICATION

On July 21, 1941, Guy E. Skaggs of Enterprise, Oregon, filed an application for approval of a change in place of use of water from Silver Creek.

Certificate of water right recorded at Page 2481, Volume 3, State Record of Water Right Certificates, was issued to W. E. Daggett (for ten others jointly interested), confirming a right to the use of the waters of Silver Creek under Permit No. 582 for the irrigation of, among other lands, 40 acres in the  $NW_4^1$   $SW_4^1$ , Section 15, Township 2 South, Range 44 East, W. M., with a date of priority of October 25, 1910.

The applicant herein, owner of the above-described lands, proposes to transfer the water right therefrom to 20 acres in the  $SE_4^1$   $SE_4^1$ , Section 8, and 20 acres in the  $NE_4^1$   $NE_4^1$ , Section 17, Township 2 South, Range 44 East, W. M.

Notice by publication as provided by Section 116-606, O. C. L. A., was not given in connection with this application for the reason that said section provides that notice is not required in applications for only a change in place of use of water.

The Silver Creek Ditch Company, through its President, L. M. Cook, and Secretary and Treasurer, F. D. Zollman, has submitted written approval of the proposed transfer, and it appearing that the proposed change may be made without injury to existing rights the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use of water be and the same hereby is approved and that the water right hereinbefore described as appurtenant to 40 acres in the  $NW_4^1$   $SW_4^1$ , Section 15, Township 2 South, Range 44 East, W. M., be severed therefrom and simultaneously and without loss of priority transferred to 20 acres in the  $SE_4^1$   $SE_4^1$ , Section 8, and 20 acres in the  $NE_4^1$   $NE_4^1$ , Section 17, Township 2 South, Range 44 East, W. M.

It is FURTHER ORDERED that complete application of water to beneficial use upon the lands to which the water hereby is transferred shall be made on or before October 1, 1943, or such extension of time as may be granted by the State Engineer for good cause shown.

It is FURTHER ORDERED that upon receipt of proof satisfactory to the State Engineer of the complete application of water to beneficial use upon the lands to which the water hereby is transferred a certificate shall be issued to W. E. Daggett (for ten others jointly interested) and that the certificate of water right heretofore issued to W. E. Daggett (for ten others jointly interested) and recorded at Page 2481, Volume 3, State Record of Water Right Certificates, shall be cancelled.
