ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7135 submitted by

SHARON WOOD DAVISON 2858 EAST FORK ROAD WILLIAMS OR 97544

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON COUNTY as evidenced by a portion of Certificate 68753. The decree is recorded in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is OCTOBER 4, 1899.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must filed within the 60 day time period specified by ORS 183.484(2).

This statement of judicial review is required by ORS 536.075; it does not alter or add to existing review right or create review rights that are not otherwise provided by law.

The right allows the use of GLADE FORK, a tributary of WILLIAMS CREEK, for IRRIGATION OF 3.5 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.09 cubic foot per second, if available at the authorized point of diversion: SE% SE%, SECTION 15, T 39 S, R 5 W, W.M.; 110 FEET NORTH AND 940 FEET WEST FROM THE SE CORNER OF SECTION 15, or its equivalent in case of rotation, measured at the point of diversion from the source.

The authorized place of use is located as follows:

SW% NW% 1.8 ACRES

TOWNSHIP 39 SOUTH, RANGE 5 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

The applicant proposes to change the place of use to:

- 1. The proposed change shall be completed on or before October 1, 2001.
- 2. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 68753 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
