ORDER APTROVING

On April 3, 1967, Lester H. Reed filed an application in the office of the State Engineer for the approval of a change in place of use of water from Eiler Creek, pursuant to the provisions of ORS 540.510 to 540.530.

certificate of water right issued to Archie B. Curwick and recorded at page 20027, Volume 14, State Record of Water Right Certificates, confirms a right to the use of the waters of Eiler Creek for the irrigation of, among other lands, 1.4 acres in the NEW NEW, and 2.6 acres in the SEW NEW, Section 7, and 2.0 acres in the NEW NEW, Section 8, Township 1 North, Range 4 West, J.M., with a date of priority of March 19, 1947.

The applicant herein, owner of the lands above described, proposes to transfer the water right therefrom without loss of priority to 4.0 acres in the SW/NS/, Section 7, and 2.0 acres in the SW/NS/, Section 8, Township 1 North, Range 4 West, W.M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason that said section provides notice is not required on an application for a change in place of use of water only.

Fr. Clayton J. Gardner, Watermaster of District No. 1, has filed a report to the effect that the proposed change in place of use of water may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use of water may be made without injury to existing rights, the application should be approved.

NOW, THEREFORM, it hereby is ORDERED that the proposed change in place of use of water is approved and the water right hereinbefore described as appurtenant to 1.4 acres in the NEW NEW, and 2.6 acres in the SEM NEW, Section 7, and 2.0 acres in the NWA NWA, Section 8, Township 1 North, Range 4 West, W.M., with a date of priority of March 19, 1947, be severed therefrom and simultaneously and without loss of priority transferred to 4.0 acres in the SW4 NEW4, Section 7, and 2.0 acres in the SW4 NW4, Section 8, Township 1 North, Range 4 West, W.M.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1968.

or right heretofore It is FURTHER ORDERED that certificate c issued to Archie B. Curwick and recorded at pa @ 20027, Volume 14, State Record of Water Right Certificates, is canceled and up (receipt of proof satisfactory to the State Engineer of completion of the authorized change in place of use, a certificate of water right shall be issued to Lester H. Reed confirming the extent to which the water has been applied beneficially and covering the lands not involved in this proceeding.
