## ORDER AMENDING A FINAL ORDER

Pursuant to ORS 541.329 (District Water Rights Mapping Provision, HB 3111) a Final Order dated June 19, 1997, recorded at Volume 51, Page 860 to 885 was issued to Farmers Irrigation District.

No where in the Final Order was it described that Transfer 5477 would be included with the land under Farmers Irrigation District's petition. This fact was reported in "Report on Findings of the Farmers Irrigation District HB 3111 Petition" under "Eligible Water Rights" that T-5744 would be confirmed as part of the petition. In actual fact, T-5744 was petitioned and included as part of Farmers Irrigation District's petition. All acreage listing in the Final Order for what was Certificate 47710, priority May 7, 1906 included the land under Transfer 5477.

Current language in the Final Order is:

Page 861, paragraph 1, line 1 reads:

"Attachment 1 lists the said perfected rights ordered by priority date."

Page 862, paragraph 3, line 1 reads:

"The petitioner has requested all perfected water rights eligible to be petitioned."

Proposed language for the Final Order is:

Page 861, paragraph 1, line 1 reads:

"Attachment 1 lists the said perfected rights, including Transfer 5477, ordered by priority date."

Page 862, paragraph 3, line 1:

"The petitioner has requested all perfected water rights, including Transfer 5477 eligible to be petitioned."

Three typographical errors were also identified in the same Final Order listed above. They are:

Page 867.

The first block of land in the table is listed under Certificate "46594".

Page 871

The first block of land in the table is listed under Certificate "46594".

Page 872

The last block of land in table is listed under Certificate Phelps. The use (P/S column) is listed as "P" for primary.

The proposed language is:

Page 867

The first block of land in the table should be listed under Certificate "46954".

Page 871

The first block of land in the table should be listed under Certificate "46954".

Page 872

The last block of land in table is listed under Certificate Phelps. The use (P/S column) would be "S" for supplemental.

Also, Certificate 74306 was issued to confirm Farmers Irrigation District's petition under ORS 541.329. On the last page (34 of 34) the second paragraph reads:

"This certificate confirms orders of the Director entered on June 19, 1997 and recorded in Special Order Volume 51, page 860, approving a petition by FARMERS IRRIGATION DISTRICT under ORS 541.329 for mapping water rights within a district. This certificate together with Certificate 74307 supersedes Certificate 47710."

The proposed language for this paragraph:

"This certificate confirms an order of the Director entered on June 19, 1997 and recorded in Special Order Volume 51, page 860, approving a petition by FARMERS IRRIGATION DISTRICT under ORS 541.329 for mapping water rights within a district and Special Order Volume 40, page 49, approving Transfer 5477. This certificate together with Certificate 74307 supersedes Certificate 47710."
