IN THE MATTER OF THE APPLICATION OF STEVEN L. STEIDL FOR APPROVAL OF A CHANGE IN PLACE OF USE OF WATER FROM DESCHUTES RIVER.

ORDER APPROVING APPLICATION

On December 31, 1941, Steven L. Steidl, Box 1009, Bend, Oregon, filed an application for approval of a change in place of use of water from Deschutes River.

By an order of the State Engineer dated July 22, 1940, an application was approved for a change in place of use of water from 20 acres in the $SW_4^{\frac{1}{4}}$ NE $_4^{\frac{1}{4}}$, Section 29, Township 17 South, Range 12 East, W. M., to 10 acres in the $SW_2^{\frac{1}{4}}$ SE $_4^{\frac{1}{4}}$, Section 20, and 10 acres in the $SW_2^{\frac{1}{4}}$ NE $_4^{\frac{1}{4}}$, Section 29, Township 17 South, Range 12 East, W. M., with a date of priority of October 10, 1903.

The applicant herein, owner of the above-described land, proposes to transfer 2 acres in the $SW_4^{\frac{1}{4}}$ $SE_4^{\frac{1}{4}}$, Section 20, and 1 acre in the $SW_4^{\frac{1}{4}}$ $NE_4^{\frac{1}{4}}$, Section 29, Township 17 South, Range 12 East, W. M., to 1 acre in the $SW_4^{\frac{1}{4}}$ $NE_4^{\frac{1}{4}}$ and 2 acres in the $SE_4^{\frac{1}{4}}$ $NE_4^{\frac{1}{4}}$, Section 29, Township 17 South, Range 12 East, W. M.

Notice by publication as provided by Section 116-606, O. C. L. A., was not given in connection with this application for the reason that said section provides that notice is not required in applications for only a change in place of use of water.

It appears that such change in place of use of water may be made without injury to existing rights and the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use of water be and the same hereby is approved and the water right hereinbefore described as appurtenant to 2 acres in the SW_4^{\perp} SE_4^{\perp} , Section 20, and 1 acre in the NW_4^{\perp} NE_4^{\perp} , Section 29, Township 17 South, Range 12 East, W. M., be severed therefrom and simultaneously and without loss of priority transferred to 1 acre in the SW_4^{\perp} NE_4^{\perp} and 2 acres in the SE_4^{\perp} NE_4^{\perp} , Section 29, Township 17 South, Range 12 East, W. M.

It is FURTHER ORDERED that complete application of water to beneficial use on said land shall be made on or before October 1, 1943, or such extension of time as may be granted by the State Engineer for good cause shown.

It is FURTHER ORDERED that a certificate of water right shall be issued to Steven L. Steidl, or his successor-in-interest, when and at the time certificates of water right are issued in connection with the Deschutes River adjudication proceedings.
