ORDER APPROVING CHANGES IN USE, PLACE OF USE,  
AND POINTS OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6831 submitted by

PARKER NORTHWEST PAVING COMPANY  
P.O. BOX 149  
OREGON CITY, OREGON 97013.

The right to be modified, as evidenced by Certificate 15153, was perfected under Permit 15447 with a date of priority of MARCH 25, 1943. The right allows the use of the MOLALLA RIVER, a tributary of the WILLAMETTE RIVER, for MANUFACTURING. This right is limited to 1.11 cubic foot per second, if available at the authorized point of diversion: LOT 1 (SW $\frac{1}{4}$  NW $\frac{1}{4}$ ), SECTION 20, T 4 S, R 2 E, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SE $\frac{1}{4}$  NE $\frac{1}{4}$   
as projected within DLC 39  
SECTION 19  
TOWNSHIP 4 SOUTH, RANGE 2 EAST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the USE and PLACE OF USE of a portion of the manufacturing use to irrigation located as follows:

SW $\frac{1}{4}$  SW $\frac{1}{4}$  6.0 ACRES  
SE $\frac{1}{4}$  SW $\frac{1}{4}$  7.5 ACRES  
SECTION 4

NE $\frac{1}{4}$  NE $\frac{1}{4}$  26.8 ACRES  
NW $\frac{1}{4}$  NE $\frac{1}{4}$  0.2 ACRE  
SE $\frac{1}{4}$  NE $\frac{1}{4}$  10.0 ACRES  
SECTION 10

TOWNSHIP 4 SOUTH, RANGE 1 EAST, W.M.

The applicant proposes to change the PLACE OF USE of the remainder of the manufacturing use located as follows:

NW $\frac{1}{4}$  SE $\frac{1}{4}$   
SECTION 5  
TOWNSHIP 4 SOUTH, RANGE 1 EAST, W.M.

The applicant proposes to change the point of diversion to the following points of diversion:

Manufacturing: NW $\frac{1}{4}$  SE $\frac{1}{4}$ , SECTION 5, T 4 S, R 1 E, W.M.; 1100 FEET SOUTH AND 1300 FEET EAST FROM THE CENTER OF SECTION 5;


Irrigation: SE $\frac{1}{4}$  SE $\frac{1}{4}$ , SECTION 5, T 4 S, R 1 E, W.M.; 100 FEET NORTH AND 75 FEET WEST FROM THE SE CORNER OF SECTION 5.

THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1993.
2. The quantity of water diverted at the new points of diversion, shall not exceed the quantity of water available at the original point of diversion.
3. The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.
4. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
5. The former place of use shall no longer receive water as a part of this water right.

Certificate 15153 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
