FINDINGS OF FACT AND CONCLUSIONS OF LAW

A certificate of water right has previously been issued under ORS 537.407 (1) that authorizes the water uses requested in the listed applications.

Therefore, further processing of these applications would result in duplicitive and unnecessary water rights.
