On March 11, 1969, an application was filed in the office of the Water Resources Director by Roseburg Lumber Company for approval of changes in point of diversion, place of use and use theretofore made of water from Cow Creek, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 9183, Volume 9, State Record of Water Right Certificates, in the name of H. Wollenberg, describes a right for the use of not to exceed 0.38 cubic foot per second of water from Cow Creek for irrigation of 12.0 acres in NE¹/₄ SE¹/₄ and 12.0 acres in SE¹/₄ SE¹/₄ of Section 23; and 6.0 acres in NW¹/₄ SW¹/₄ of Section 24, Township 30 South, Range 6 West, W.M., with a priority date of July 31, 1924.

The point of diversion of record for said right is located 660 feet South and 480 feet East from the West Quarter Corner of Section 24, being within the NW_4 SW_4 of Section 24, Township 30 South, Range 6 West, W.M.

The applicant herein, owner of the lands above described, proposes to sever the water right therefrom and to the extent of 0.28 cubic foot per second maintained in beneficial use, without loss of priority, hereafter use the water appropriated for industrial use within the SW4 NW4, SE4 SW4, and the SE4 of Section 23; and the NE4 NW4 of Section 26, Township 30 South, Range 6 West, W.M.; and to change from the above described point of diversion to a point located 5710 feet South and 20 feet East from the Northwest Corner of D.L.C. No. 45, being within the SE4 NW4 of Section 26, Township 30 South, Range 6 West, W.M.

Notice of the application, pursuant to ORS 540.510, was published in the News-Review, a newspaper printed and having general circulation in Douglas County, Oregon, for a period of three weeks in the issues of April 3, 10 and 17, 1970.

Mr. M. John Youngquist, Watermaster, has filed a statement to the effect that the proposed changes in point of diversion, place of use and use theretofore made of water may be made without injury to existing rights. No objections having been filed and it appearing that the proposed changes in point of diversion, place of use and use theretofore made of water may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested changes in point of diversion, place of use and use theretofore made of water from Cow Creek, as described herein, without loss of priority, are approved.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion under the subject right, and shall not exceed 0.28 cubic foot per second, and shall be limited to the irrigation season of each year.

It is FURTHER ORDERED that the following provisions shall be carried out prior to the diverting of water at the new point of diversion as herein confirmed:

That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made and said water so transferred shall be applied to beneficial use on or before October 1, 1979.

It is FURTHER ORDERED that the certificate of water right heretofore issued to H. Wollenberg and recorded at page 9183, Volume 9, State Record of Water Right Certificates, is canceled; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.
