O R D E R

On April 16, 1969, Donald D. Kuenzi submitted an affidavit that he is the owner of lands claimed to have been irrigated as described in a certificate of registration; that he has abandoned said claim of water right and requests the same be canceled.

That part of the claimed right in question is for the use of not to exceed 164 gallons per minute from pump well No. 1 located north 17° west, 2640 feet from the southeast corner of Section 35, Township 6 South, Range 2 West, W.M., with a beginning date of February 10, 1954, for irrigation of 15.0 acres in NW $\frac{1}{4}$  NE $\frac{1}{4}$  and 24.0 acres in SW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 2, Township 7 South, Range 2 West, W.M., and is described in the certificate of registration recorded in Volume 5, page 832, Ground Water Registration Records.

That part of said claimed right for the use of not to exceed 336 gallons per minute from the described well for irrigation of:


5.0 acres in NE $\frac{1}{4}$  SW $\frac{1}{4}$   
20.0 acres in SE $\frac{1}{4}$  SW $\frac{1}{4}$   
11.0 acres in NW $\frac{1}{4}$  SE $\frac{1}{4}$   
32.0 acres in SW $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 35  
Township 6 South, Range 2 West, W.M.,

3.0 acres in NE $\frac{1}{4}$  NW $\frac{1}{4}$   
9.0 acres in NW $\frac{1}{4}$  NE $\frac{1}{4}$   
Section 2  
Township 7 South, Range 2 West, W.M.,

and described in said certificate, is not in question in this proceeding.

NOW, THEREFORE, it is hereby ORDERED that the claim of a water right for the use of not to exceed 164 gallons per minute from pump well No. 1 located north 17° west, 2640 feet from the southeast corner of Section 35, Township 6 South, Range 2 West, W.M., with a beginning date of February 10, 1954, for irrigation of 15.0 acres in NW $\frac{1}{4}$  NE $\frac{1}{4}$  and 24.0 acres in SW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 2, Township 7 South, Range 2 West, W.M., is canceled.
