ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

ORS 540.610 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and to voluntarily request that it be cancelled.

Findings of Fact

- 1. On September 8, 1998, William R. McAllister filed a transfer application to change the place of use under Certificates 11108, 51486, 51487, 60463, 76222, 76223 and 80637. The Department assigned the application number T-8080.
- 2. The Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-8080 to the applicant on November 30, 2006. The draft Preliminary Determination set forth a deadline in which the applicant could respond.
- 3. On December 6, 2006, oral comments were received via telephone from the applicant's agent, Larry Toll, CWRE identifying typos and errors needing correction. The Preliminary Determination issued on January 5, 2007, corrected those errors contained in the draft of the Preliminary Determination.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Partial Cancellation of a Water Right

18. On November 3, 2006, Stix LLC, Pintail LLC, John Patrick Kennedy, Mary Elizabeth Kennedy, Barry Fletcher Kennedy and Carrie Marie Kennedy, owners of certain lands to which a portion of water right Certificate 60463 is appurtenant, submitted affidavits meeting the requirements of ORS 540.621 for partial cancellation of a water right as follows:

- 19. The partial cancellation described in Finding of Fact #18 represents, as requested by the water right holder, a reduction in the number of acres to which the water may be applied under the right, but does not reduce the total cubic foot per second rate allowed under the right. Use of the full rate allowed by Certificate 60463 on the remaining acres will not increase the rate per acre beyond the nominal 1/80 cfs per acre allowed by the right.
- 20. Transfer application T-8080 is being processed concurrently with transfer applications T-9990, T-10016 and T-10028 which also affect Certificates 51486, 51487, 76222, 76223, and 80637. Upon issuance of the final orders for these transfers, Certificates 51486, 51487, 76222, 76223, and 80637 will be cancelled and new certificates will be issued describing the portions of the rights not affected by the transfers.
- 21. Notice of the application for transfer was published on August 22, 2006, pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
- 22. On January 5, 2007, the Department issued a preliminary determination proposing to approve Transfer T-8080 and mailed a copy to the applicants. Additionally, notice of the preliminary determination for the transfer application was published on the Department's weekly notice on January 9, 2007 pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

- 23. Water has been used within the last five years according to the terms and conditions of the rights, and no evidence is available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 24. Ditches, pumps, pipeline and sprinkler systems sufficient to use the full amount of water allowed under the existing rights are present.
- 25. The Department requires a suitable device for measuring and recording the quantity of water diverted under the rights. Currently the Badger Improvement District has a headgate and Parshall flume at the point of diversion that satisfies this requirement.
- 26. The proposed change would not result in enlargement of the rights.
- 27. The proposed change would not result in injury to other water rights.

Conclusions of Law

The change in place of use proposed in Transfer Application T-8080 is consistent with the requirements of ORS 540.505 to 540.580, and OAR 690-380-5000.

The portion of Certificate 60463 described in Finding #18 as abandoned will be cancelled.

Now, therefore, it is ORDERED:

- 1. The changes in place of use proposed in application T-8080 are approved. The portion of the right that has been abandoned is cancelled.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 11108, 51486, 51487, 60463, 76222, 76223 and 80637 and any related decree.
- 3. Certificates 11108, 51486, 51487, 60463, 76222, 76223 and 80637 are cancelled. New certificates will be issued describing the portions of the rights not voluntarily cancelled or transferred by T-8080, T-9990, T-10016 and T-10228.
- 4. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2008.** A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 5. The former place of use of the transferred water shall no longer receive water as part of these rights.
