ORS 540.570 establishes the process in which a district may submit a request to temporarily transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

Applicant

Findings of Fact

- 1. On March 31, 2008, Echo Irrigation District filed a district transfer application to temporarily change the place of use and points of appropriation under Certificates 80849, 80850, 80851 and Permit G-2415 (as modified under transfer application T-6787). The Department assigned the application number T-10587.
- 2. Notice of the application for transfer was published pursuant to ORS 540.580 and OAR 690-385-3400. No comments were filed in response to the notice.
- 3. Pursuant to OAR 690-385-3130 the applicant applied to temporarily change a portion of water right Certificate 80849 to supplemental irrigation at the proposed place of use during the 2008 irrigation season as described in Findings of Fact #10. Echo Irrigation District also specified water use on the authorized "FROM" lands under existing Permit G-8907 will not be used or transferred during the course of the 2008 Irrigation Season, as described in Findings of Fact #4 and #7. In addition, Echo Irrigation District also specified water use on the proposed "TO" lands under existing Certificate 76369 will not be used or transferred during the course of the 2008 Irrigation Season, as described in Findings of Fact #10 & #13.
- 4. The portion of the first primary right to be transferred is as follows:

- 15. Notice of the application for temporary transfer was published on April 15, 2008, pursuant to ORS 540.570(4). No comments were filed in response to the notice.
- 16. The Department has determined that the proposed additional points of appropriation (Coppinger New Well #1, Ditchen Well #1 and #2) are all within the same subareas (D and H) of the Stage Gulch Critical Ground Water Area and will all develop the same source of water as the authorized existing wells described in Certificates 80849, 80850 and 80851.
- 17. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- 18. The proposed changes in place of use would not result in enlargement of the rights.
- 19. The proposed changes would not result in injury to other water rights.

Conclusions of Law

The proposed TEMPORARY changes in application T-10587 satisfy the requirements of ORS 540.574(3) and 540.570.

Now, therefore, it is ORDERED:

- 1. The proposed temporary changes to the water rights evidenced by Certificates 80849, 80850 and 80851 and Permit G-2415 (as modified under transfer application T-6787) are approved.
- 2. The former places of use **shall not** be irrigated as part of these water rights during the 2008 irrigation season.
- 3. At the end of the 2008 irrigation season all use of water under this temporary transfer shall automatically revert to the terms and conditions of the original water right certificates or adjudication as evidenced by a court decree. The authorization to use the additional points of appropriation shall be terminated concurrently.
- 4. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 80849, 80850, 80851, Permit G-2415 (as modified under transfer application T-6787) and any related decree.
- 5. Use of water under Permit G-8097 is not allowed on the lands included in this transfer order during the 2008 Irrigation Season.
- 6. The use of water on the lands from which the water right is transferred and at the new temporary place of use during the same irrigation season or calendar year is prohibited and may subject the district and landowner to civil penalties.
- 7. The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.

- 8. The use of water under this temporary transfer may be conditioned or revoked at any time to the extent necessary to avoid injury if the Department finds the transfer causes injury to any existing water right.
- 9. A subsequent application for permanent transfer of Certificates 80849, 80850, 80851, Permit G-2415 (as modified under transfer application T-6787) shall be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380. Approval of this temporary transfer does not establish a precedent for approval of a subsequent application filed for a permanent transfer.
- 10. The use of water at the temporary place of use authorized by this transfer shall be in accordance with the terms and conditions of Certificates 80849, 80850 and 80851 and Permit G-2415 (as modified under transfer application T-6787).
- 11. The time during which water is used under this approved temporary transfer does not apply toward a finding of forfeiture under ORS 540.610.
- 12. The use of the remaining water rights described by Certificates 80849, 80850 and 80851 and Permit G-2415 (as modified under transfer application T-6787) shall continue to be in accordance with the terms and conditions of Certificates 80849, 80850 and 80851 and Permit G-2415 (as modified under transfer application T-6787).
- 13. The District shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.
