On December 23, 1963, Mr. James W. Oades submitted a sworn statement that he is the legal owner of a certain water right and the real property to which the right is appurtenant; that the lands described are incorrectly located and requesting the State Engineer to issue a new certificate so as to correctly locate the lands irrigated as shown by the map submitted with the affidavit.

The water right in question is that evidenced by the certificate recorded at page 11139, Volume 10, State Record of Water Right Certificates and is for the appropriation of not to exceed 0.50 cubic foot per second from Fivemile Creek and two springs, with a date of priority of January 26, 1929, for irrigation of 15 acres in  $SW_{4}^{\frac{1}{4}}$   $NE_{4}^{\frac{1}{4}}$ , 10 acres in  $NW_{4}^{\frac{1}{4}}$   $NE_{4}^{\frac{1}{4}}$  and 15 acres in  $NE_{4}^{\frac{1}{4}}$   $NE_{4}^{\frac{1}{4}}$ , Section 35, Township 1 North, Range 13 East, W. M.

From the evidence submitted it appears that an error was made in the preparation of the application map and that a new certificate should be issued correctly locating the lands irrigated.

NOW, THEREFORE, it hereby is ORDERED that the certificate recorded at page 11139, Volume 10, State Record of Water Right Certificates, is canceled and in lieu thereof a certificate shall be issued to James W. Oades for the use of 0.50 cubic foot per second of the waters

of Fivemile Creek and two springs for the irrigation of 10 acres in the  $NE_{4}^{\frac{1}{4}}$ ,  $NE_{4}^{\frac{1}{4}}$ , 6 acres in the  $SW_{4}^{\frac{1}{4}}$   $NE_{4}^{\frac{1}{4}}$ , 15 acres in the  $SE_{4}^{\frac{1}{4}}$   $NE_{4}^{\frac{1}{4}}$ , Section 35, and 9 acres in the  $NW_{4}^{\frac{1}{4}}$   $NW_{4}^{\frac{1}{4}}$ , Section 36, Township 1 North, Range 13 East, W. M. with a date of priority of January 26, 1929.
