ORDER APPROVING ADDITIONAL POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves TRANSFER 6340 submitted by

WEYERHAEUSER (AURORA FOREST NURSERY) 6051 SOUTH LONE ELDER ROAD AURORA, OREGON 97002

to use the waters of FIVE WELLS in the PUDDING RIVER BASIN for the purpose of the PRIMARY IRRIGATION OF 8.0 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 20.5 ACRES.

The right to be transferred, as evidenced by certificate 41987, was perfected under Permit G-4005 with a date of priority of FEBRUARY 21, 1968. The right is limited to 0.10 cubic foot per second, if available at the original well; WELL 10 - NW 1/4 SE 1/4, SECTION 7, T 4 S, R 1 E, W.M.; 2130 FEET NORTH AND 1500 FEET WEST FROM THE SE CORNER OF SECTION 7, or its equivalent in case of rotation, measured at the we'l.

The right to be transferred, as evidenced by certificate 52345, was perfected under Permit G-6506 with a date of priority of JUNE 20, 1975. The right is limited to 0.26 cubic foot per second, if available at the original well; WELL 5 - SW 1/4 SE 1/4, SECTION 7, T 4 S, R 1 E, W.M.; 1130 FEET NORTH AND 1330 FEET WEST FROM THE SE CORNER OF SECTION 7, or its equivalent in case of rotation, measured at the well.

The new points of appropriation are located as follows:

SW 1/4 SE 1/4, SECTION 7; NW 1/4 NE 1/4, NE 1/4 NW 1/4, SECTION 18, T 4 S, R 1 E, W.M.; WELL 15 - 750 FEET NORTH AND 2400 FEET WEST; WELL 6 - 840 FEET SOUTH AND 2170 FEET WEST; WELL 14 - 880 FEET SOUTH AND 2240 FEET WEST; ALL FROM THE NE CORNER OF SECTION 18.

The amount of water used for irrigation under these rights is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use is as follows:

FEBRUARY 21, 1968 JUNE 20, 1975

NW 1/4 SE 1/4 7.7 ACRES

SW 1/4 SE 1/4 8.0 ACRES 12.8 ACRES

SECTION 7

TOWNSHIP 4 SOUTH, RANGE 1 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change is reported complete. The claim of beneficial use shall be submitted in accordance with the instructions in the transmittal letter.
- 2. The quantity of water diverted at the new points of appropriation shall not exceed the quantity of water available from the original points of appropriation.
- 3. When required by the Department the water user shall install an inline flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. If needed to prevent injury to existing water rights, the wells at the new points of appropriation shall be constructed to the well construction standards in effect as of the date of this order and must include access ports.
- 5. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificates 41987 and 52345 are hereby canceled. When satisfactory proof of the completed change is received, new certificates confirming these water rights will be issued.
