**ORDER APPROVING CHANGES IN PLACE OF USE
AND POINTS OF APPROPRIATION**

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6864 submitted by

The first right to be modified, as evidenced by a PORTION of Certificate 53456, was perfected under Permit G-9118 with a date of priority of JULY 15, 1980. The right allows the use of WELLS 1 (now Well 2), 2 (now Well 1), and 3, tributaries of the FORT ROCK BASIN, for IRRIGATION OF 17.9 ACRES. The amount of water to which this right is entitled is limited to 0.22 cubic foot per second, being 0.06 cfs from WELL 1 (now Well 2), 0.07 cfs from WELL 2 (now Well 1), and 0.09 cfs from WELL 3, if available at the original wells; NE¼ NW¼, NE¼ SW¼, & NW¼ SW¼, SECTION 8, T 27 S, R 17 E, W.M.; WELL 1 (now Well 2) - 1320 FEET SOUTH AND 1280 FEET WEST, WELL 2 (now Well 1) - 3950 FEET SOUTH AND 1320 FEET WEST, WELL 3 - 2670 FEET SOUTH AND 2410 FEET WEST, ALL FROM THE NORTH ¼ CORNER OF SECTION 8, or its equivalent in case of rotation, measured at the well.

The second right to be modified, as evidenced by a PORTION of Certificate 53457, was perfected under Permit G-9125 with a date of priority of JANUARY 13, 1981. The right allows the use of WELL 1 (now Well 8), a tributary of the FORT ROCK BASIN, for IRRIGATION OF 1.7 ACRES. The amount of water to which this right is entitled is limited to 0.02 cubic foot per second, if available at the original well; NW¼ SW¼, SECTION 3, T 25 S, R 16 E, W.M.; Well 1 (now Well 8) - 1340 FEET NORTH AND 1320 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 3, or its equivalent in case of rotation, measured at the well.

The third right to be modified, as evidenced by a PORTION of Certificate 53458, was perfected under Permit G-9126 with a date of priority of JANUARY 13, 1981. The right allows the use of WELLS 1 (now Well 7) and 2 (now Well 6), tributaries of the FORT ROCK BASIN, for IRRIGATION OF 9.9 ACRES. The amount of water to which this right is entitled is limited to 0.12 cubic foot per second, being 0.08 cfs from WELL 2 (now Well 6) and 0.40 cfs from WELL 1 (now Well 7), if available at the original wells; SW¼ NW¼ & SW¼ SW¼, SECTION 23, T 26 S, R 16 E, W.M.; WELL 2 (now Well 6) - 3940 FEET NORTH AND 1320 FEET WEST, WELL 1 (now Well 7) - 1320 FEET NORTH AND 1320 FEET WEST, BOTH FROM THE SOUTH ¼ CORNER OF SECTION 23, or its equivalent in case of rotation, measured at the well.

The fourth right to be modified, as evidenced by a PORTION of Certificate 53459, was perfected under Permit G-9127 with a date of priority of JANUARY 13, 1981. The right allows the use of WELLS 1(now Well 5) and 2 (now Well 4), tributaries of the FORT ROCK BASIN, for IRRIGATION OF 6.7 ACRES. The amount of water to which this right is entitled is limited to 0.08 cubic foot per second, being 0.04 cfs from WELL 2 (now Well 4) and 0.4 cfs from WELL 1 (now Well 5), if available at the original wells; NW¼ NE¼ & SW¼ SE¼, SECTION 26, T 26 S, R 16 E, W.M.; WELL 2 (now Well 4) - 1310 FEET NORTH AND 1300 FEET EAST, WELL 1 (now Well 5) - 3960 FEET NORTH AND 1300 FEET EAST, BOTH FROM THE SOUTH ¼ CORNER OF SECTION 26, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

TOWNSHIP 26 SOUTH, RANGE 16 EAST, W.M.

The applicant proposes to change the point of appropriation for the lands in Section 3 to:

NW¼ SW¼, SECTION 3, T 25 S, R 16 E, W.M.; WELL 8 - 1340 FEET NORTH AND 1320 FEET EAST FROM THE SOUTHWEST CORNER, SECTION 3.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THESE CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed changes shall be completed on or before October 1, 1999.
2. The quantity of water diverted at the new points of appropriation (wells), together with the quantity diverted at the old points of appropriation, shall not exceed the quantity of water available from the original points of appropriation.
3. When required by the Department the water user shall install in-line flow meters or other suitable devices for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original points of appropriation.

5. The former places of use shall no longer be irrigated as part of this water right.

Certificates 53456, 53457, 53458 AND 53459 are canceled. New certificates will be issued to confirm those portions of the rights NOT involved in this transfer. When satisfactory proof of the completed change is received, new certificates confirming these water rights will be issued.
