ON DECEMBER 3, 1992, THE SPECIAL ORDER WAS ENTERED AT VOLUME 46, PAGES 524 AND 525, BY THE WATER RESOURCES DIRECTOR CANCELING, AMONG OTHERS, PERMIT 51141.

AN ORDER OF THE DIRECTOR IS FINAL AFTER 60 DAYS HAS PASSED FROM THE DATE THE ORDER WAS ENTERED. IF THE DIRECTOR IS PETITIONED WITHIN SAID 60 DAY PERIOD, ALL OR A PORTION OF SAID ORDER MAY BE RECONSIDERED. THE ORDER MAY BE AMENDED IF A REQUEST TO RECONSIDER IS FILED TIMELY.

PETER DINSDALE SUBMITTED A WRITTEN STATEMENT THAT USE WAS MADE UNDER THE TERMS OF THE PERMIT.

THE SPECIAL ORDER OF THE WATER RESOURCES DIRECTOR ENTERED DECEMBER 3, 1992, AT VOLUME 46, PAGES 524 AND 525, SHOULD BE AMENDED TO DELETE THE FOLLOWING PERMIT FROM SAID ORDER:
