ORDER APPROVING A CHANGE IN CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6975 submitted by

WASCO COUNTY
511 WASHINGTON STREET
THE DALLES, OREGON 97058.

The right to be modified, as evidenced by a PORTION of Certificate 63798, was perfected under Permit 24611 with a date of priority of NOVEMBER 23, 1956. The right allows the use of A SPRING, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 1.2 ACRES. This right is limited to 0.018 cubic foot per second, if available at the authorized point of diversion: LOT 1 (NE $\frac{1}{4}$ SE $\frac{1}{4}$), SECTION 17, T 2 N, R 13 E, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

LOT 2 (NW $\frac{1}{4}$ SW $\frac{1}{4}$) 0.2 ACRE
SECTION 16

LOT 1 (NE $\frac{1}{4}$ SE $\frac{1}{4}$) 1.3 ACRES
SECTION 17
TOWNSHIP 2 NORTH, RANGE 13 EAST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the place of use to:

LOT 2 (NW $\frac{1}{4}$ SW $\frac{1}{4}$) 0.6 ACRE
LOT 1 (SW $\frac{1}{4}$ SW $\frac{1}{4}$) 0.9 ACRE
SECTION 16
TOWNSHIP 2 NORTH, RANGE 13 EAST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1995.

2. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 63798 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
