## ORDER APPROVING A CHANGE IN CHARACTER OF USE AND A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7923 submitted by

LAURELWOOD WATER USERS CO-OPERATIVE 38660 SW HARTLEY ROAD GASTON, OREGON, 97119.

The right to be modified, as evidenced by a portion of Certificate 2879, was perfected under Permit 3772 with a date of priority of JANUARY 30, 1917. The right allows the use of SPRING 1, a tributary of FRANK WALKER CREEK, for DOMESTIC SUPPLIES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.69 cubic foot per second, if available at the authorized point of diversion, or its equivalent in case of rotation, measured at the point of diversion from the source.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to change the place of use to:

ALL SECTIONS 4, 5, 6, AND 8

> E½ SECTION 7

TOWNSHIP 2 SOUTH, RANGE 3 WEST, W.M.

The applicant proposes to change the character of use from DOMESTIC SUPPLIES to QUASI-MUNICIPAL USE.

THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed changes shall be completed on or before October 1, 2008.
- The former place of use shall no longer be irrigated as a part of this water right.

Certificate 2879 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
