
On February 7, 1966, Ira V. and Helen Ann Woolfolk submitted an affidavit that they are the legal owners of the NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 4, Township 36 South, Range 1 East, W.M., and the water rights thereto; that they have abandoned any and all interest in and to said water rights and request the same to be canceled.

The water rights in question are for the use of not to exceed 0.09 cubic foot per second of the waters of School House Creek and Woolfolk Reservoir for the supplemental irrigation of 7.1 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 4, Township 36 South, Range 1 East, W.M., with a date of priority of June 1, 1954, and is evidenced by certificate of water right issued in the name of Ira V. Woolfolk and recorded at page 31157, Volume 23, State Record of Water Right Certificates; and for the use of not to exceed 0.09 cubic foot per second of the waters of Rock Creek and Woolfolk Reservoir for the supplemental irrigation of 7.1 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 4, Township 36 South, Range 1 East, W.M., with a date of priority of January 12, 1956, and is evidenced by certificate of water right issued in the name of Ira V. Woolfolk and recorded at page 31159, Volume 23, State Record of Water Right Certificates.

The remaining rights to the use of these waters as confirmed by certificates of water rights as recorded at pages 31157 and 31159, Volume 23, were transferred by Special Order dated June 30, 1966, and recorded at page 147, Volume 15, being transfer number W-115.

NOW, THEREFORE, it is hereby ORDERED that the right to the use of not to exceed 0.09 cubic foot per second of the waters of School House Creek and Woolfolk Reservoir, for the supplemental irrigation of 7.1 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 4, Township 36 South, Range 1 East, W.M., with a date of priority of June 1, 1954, as evidenced by certificate recorded at page 31157, Volume 23, State Record of Water Right Certificates; and for the use of not to exceed 0.09 cubic foot per second of the waters of Rock Creek and Woolfolk Reservoir, for the supplemental irrigation of 7.1 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 4, Township 36 South, Range 1 East, W.M., with a date of priority of January 12, 1956, as evidenced by certificate recorded at page 31159, Volume 23, State Record of Water Right Certificates, are canceled.
