**ORDER APPROVING A CHANGE IN PLACE OF USE
AND DIMINISHMENT OF A WATER RIGHT**

Pursuant to ORS 540.580, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8898, a petition submitted by

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the certificate or decree.

Diminishment of a Water Right

On January 18, 2002, the Department received a signed affidavit from William H. Wright, requesting 11.9 acres of the groundwater right appurtenant to his property under Permit G-13169 be diminished from primary to supplemental irrigation.

The portion of Permit G-13169 diminished from primary to supplemental irrigation is for the use of 0.149 cubic foot per second from Well #3, for irrigation of 11.9 acres located as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$ 11.9 ACRES
SECTION 12
TOWNSHIP 4 NORTH, RANGE 29 EAST, W.M.


The portion of Certificate 74662 transferred (as described in Table B.) to 11.9 acres located within Tax Lot 2800, SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 12, T 4 N, R 29 E, WM., will serve as primary irrigation for these acres.

THESE CHANGES TO EXISTING DISTRICT WATER RIGHTS MAY BE MADE
PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed changes shall be completed on or before October 1, 2003.
2. The former places of use shall no longer be irrigated as a part of these water rights.
3. Proof, to the satisfaction of the Director, that the changes approved by this order have been completed must be submitted by STANFIELD IRRIGATION DISTRICT on or before October 1, 2004.
4. Except as modified herein, all other conditions and restrictions of Certificates 74662 and 79440 remain in effect.
5. When the Director determines that it is necessary, or to facilitate records keeping, new certificates will be issued to confirm all completed changes for which satisfactory proof has been made and to confirm that portion of the right not modified by this or any other order.

In addition, Permit G-13169 is diminished to supplemental irrigation as described above.
